2. Who has the discretion to extend the leases?

RESPONSE: FEMA Assistant Administrator for the recovery is authorized to approve extension of the Direct Lease Program.

3. Are the lessors' permissions required for the extensions?

RESPONSE: The lessors' permission is not required to approve extension of the Direct Lease Program.

4. What is the likelihood for the leases to be extended?

RESPONSE: FEMA will evaluate the continuing need for the Direct Lease Program at the time the extension is submitted.
