AUTHORIZING THE TRANSFER OF AN
UNENCUMBERED APPROPRIATION BALANCE
WITHIN THE DEPARTMENT OF WATER SUPPLY,
FISCAL YEAR 2024 BUDGET

WHEREAS, Section 9-10(2) of the Revised Charter of the County of Maui (1983), as amended (“Charter”), provides that, upon written request of the Mayor, part or all of any unencumbered appropriation balance may be transferred within a department by resolution or from one department to another by ordinance; and

WHEREAS, Section 7 of the General Budget Provisions in Ordinance No. 5528, Bill No. 22, CD1, FD2 (2023), as amended, (“Fiscal Year 2024 Budget”), states that, unless otherwise provided, appropriations for each program may be disbursed for the following categories of use: (A) salaries, premium pay, or reallocation pay, and (B) operations, services, and equipment; provided the disbursement is within the program and category of use for which it was appropriated; and

WHEREAS, Section 3.B.18 of the Fiscal Year 2024 Budget, relating to the Department of Water Supply, sets forth appropriations for the Administration Program – Water Fund and Departmental Expenses – Water Fund; and

WHEREAS, in accordance with Section 9-10(2) of the Charter, Mayor Richard T. Bissen, Jr. has submitted a written request to transfer an unencumbered appropriation balance of \$184,000 within the Department of Water Supply, from the Administration Program – Water Fund, Category B (Operations & Equipment), to Departmental Expenses – Water Fund, Insurance, Category B (Operations & Equipment), in order to cover \$184,000 in increased insurance costs; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That, pursuant to Section 9-10(2) of the Charter and Section 7 of the General Budget Provisions, and in accordance with the Fiscal Year 2024 Budget, it does hereby authorize the transfer for the Department of Water Supply, from the Administration Program – Water Fund, Category B (Operations & Equipment), to Departmental Expenses – Water Fund,

Insurance, Category B (Operations & Equipment), in order to cover \$184,000 in increased insurance costs; and

2. That certified copies of this resolution be transmitted to the Mayor, Managing Director, Director of Finance, and Budget Director.
