I worked at Weston Kaanapali Ocean Resort Villas and noticed the Kahekili Beach had dozens of puffer fish dead along the shore. The fish were the size of deflated soccer balls. Normally they swim right along the shorebreak zone. I believe pollutants caused them to die. University of Hawaii Maui College students conducted tests on the ocean water there and the water had high bacteria levels, unsafe for humans and fish. Also, dye in the wastewater showed up in the ocean. So basically the filthy water was human waste. That's disgusting. It's unsafe for humans, the marine life that depends on that area, Native Hawaiians who gather and fish from that area, children and families who swim and enjoy the waters there. The future looks dim unless the county tries harder to resolve this situation immediately.
