CONSENT DECREE SEWER REHABILITATION PROJECT

EASEMENT 5

SITUATED ON THE SOUTHEASTERLY SIDE OF KAMEHAMEHA AVENUE AT KAHULUI, MAUI, HAWAII

BEING A PORTION OF GRANT 3343 TO CLAUS SPRECKELS

An Easement (15.00 feet wide) for sewer purposes affecting Lot 1, Island Dodge Subdivision, in favor of the Department of Environmental Management, County of Maui and described as follows:

Beginning at the Northwest corner of this Easement, on the Southeasterly side of Kamehameha Avenue, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being 3,580.11 feet North and 11,717.74 feet East, thence running by azimuths measured clockwise from True South:

- 1. 307° 03' 237.84 feet along the remainder of Lot 1;
- 2. 36° 25' 15.00 feet along Lot 19 (Ditch Lot), Maui Industrial Park No. 2;
- 3. 127° 03' 237.96 feet along the remainder of Lot 1;
- 4. Thence, along Kamehameha Avenue on a curve to the left with a radius of 622.96 feet, the radial azimuth to the point of curve being 307° 34' and the radial azimuth to the point of tangent being 306° 25', the chord azimuth and distance being:

216° 59' 30"

12.50 feet;

2.50 feet along Kamehameha Avenue to the point of beginning and containing an area of 3,568 Square Feet.
