Dear Major Arakawa and Maui County Council:

The undersigned is retained to represent Councilmember Alika Atay, Trinette Furtado and Brian Bardelini who were denied conflict counsel to represent their interests in upholding the public trust. My clients reserve the right to seek appropriate means of redress, including without limitation, potential claims for injunctive relief and reimbursement for attorney's fees and costs incurred due to denial for request of conflict counsel.

It appears a media firestorm has resulted from the alleged interactions between my clients and other council members and/or staff. Due to the serious nature of the allegations raised against my clients and vice versa, it would be in everyone's best interests to maintain status quo and carry discussions that involve highly sensitive alleged misconduct of government officials in executive session rather than aired in the public. That said, this letter puts the County of Maui on notice that my clients reserve the right to seek appropriate redress for any torts committed against them to date and in the future, including but not limited to slander, libel, invasion of privacy, etc.

Based on the information provided by my clients, a thorough investigation is in order and to be conducted as soon as possible regarding the County of Maui's fiduciary duty to properly spend public funds that the public has entrusted to the County. If you have any evidence that disputes the claims put forth, I would request you forward such evidence immediately for consideration of possible defenses of my clients' potential claims.

My clients request that several council members and government officials be investigated for misconduct and politically motivated retaliation. I urge all government officials and their staff to cease and desist from using the news as a vehicle to spread
