Arakawa notified the Council he nominated Lori Sablas to the Maui County Cultural Resources Commission for a term expiring on March 31, 2019, to fill a vacancy replacing Arleen Ricalde-Garcia, pursuant to Sections 2.40.110 and 2.88.030, Maui County Code, and Section 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and


WHEREAS, Charter Section 13-2, requires the Mayor's nominee to be approved by the Council; and

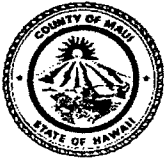
