
Thank you for your request. Here is the status update on line item 903161B-6317, as noted in the FY23 Budget. The Office of Innovation and Sustainability (formerly CCRS) executed G5804 and G5803 through Maui Environmental Consulting, LLC comprised of Michael Reyes, Principal/Senior Ecologist, and Katie Woodbury, Ecologist, for the creation of a Mā'alaea Bay (Waikapū and Waiakoa) Watershed Management Plan, fully funded in the amount of \$550,000, and the Kēōkea Riparian Rehabilitation Phase II project, fully funded in the amount of \$49,950, respectively. The Mā'alaea Bay Watershed Management Plan was submitted and approved by the Hawaii Department of Health and the U.S. Environmental Protection Agency in the 2nd Quarter of FY24. The Kēōkea Riparian Rehabilitation Phase II project expanded the scope of the Kēōkea Gulch Riparian Corridor Rehabilitation Project located in Tax Map Key (TMK) 2-2-002:084 with an additional 1.6 acres of the riparian corridor just mauka of the previous phase, replete with 750 ft. of game fencing and approximately 1,000 native plants. Both projects are complete and all associated invoices have been paid.
