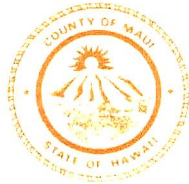

SUBJECT: **AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET
(APPENDIX A, PART I, DEPARTMENT OF HOUSING AND
HUMAN CONCERNS, AMERICAN RESCUE PLAN ACT,
HOMEOWNER ASSISTANCE FUND)**

On behalf of the Department of Housing and Human Concerns, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, APPENDIX A, PART I, DEPARTMENT OF HOUSING AND HUMAN CONCERNS, AMERICAN RESCUE PLAN ACT, HOMEOWNER ASSISTANCE FUND."

The purpose of the proposed bill is to amend the Fiscal Year ("FY") 2024 Budget Appendix A, Part I, Department of Housing and Human Concerns, to add a new appropriation for American Rescue Plan Act of 2021 – Homeowner Assistance Fund in the amount of \$16,425,000.

These funds are a supplemental award from the State of Hawai'i to assist homeowners impacted by the COVID-19 pandemic. The State elected to

reprogram the remaining funds of the Oahu allocation to the County of Maui. The State Budget and Finance Department has worked to amend the State Plan to allow for homeowners in Lāhainā to be presumptively eligible because, as a tourist destination, it was economically impacted by COVID. The federal government has also relaxed the eligibility to allow for more people to be able to receive the funding.

A contract with Catholic Charities for the original funding of \$8,060,550, which was added to the Fiscal Year 2022 Budget by Ordinance 5332, is now in final review. The vendor's attorney has approved their signing as soon as the pending changes have been made, and they expect to open the program to applicants in April. The contract will be amended to add additional funds once the program is up and running.
