The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget to 1) increase Estimated Revenues, Carryover/Savings, General Fund by \$800,000; 2) amend Capital Improvement Projects to increase the appropriation for Department of Police, Countywide, Countywide Police Facilities in the amount of \$800,000, 3) increase the Total Capital Improvement Project Appropriations and Total Appropriations by the same amount; and 4) and amend Appendix C, Department of Police, Countywide, to update the project description and increase the appropriation for Countywide Police Facilities in the amount of \$800,000.

The Wailuku Generator Project was included in the Fiscal Year 2025 Budget, but the proposals received are higher than the \$500,000 initially budgeted. As the calendar year is almost over, this amendment is for the total cost of the project as there is not sufficient time to encumber the Fiscal Year 2025 funding.
