- 3. How will vendor contracts for the pro shop, including the cart rentals and driving range, and restaurant at the Waiehu Golf Course be affected should the golf course closes on December 31, 2017? (RH)

- 4. How is the supplemental transfer to the golf fund calculated? What expenses are covered by the supplemental transfer? Is the transfer necessary or can it be reduced? (EC)
