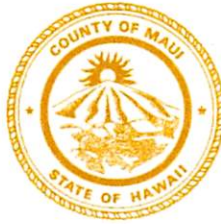

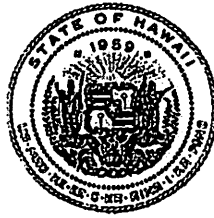

SUBJECT: INTENT TO AWARD STATE FUNDS FOR KUPUNA CARE FOR
SFY 2020

Subject to the availability of funds, the Executive Office on Aging (EOA) intends to award the County of Maui, Maui County Office on Aging state general funds for the fiscal year 2020 in the following amounts:

Kupuna Care funds	Provision of services for older adults, ages 60 and older to address long term services and supports needs	\$678,778.00
Elder Abuse funds	Provision of services to support vulnerable older adults	\$27,686.00
Kupuna Caregiver funds	Provision of services to support eligible, working caregivers	\$209,745.00
ADRC funds	Funds to support the county ADRC operational model	\$383,576.00

Please be advised that funds are based on a funding formula EOA utilizes to disperse state funds between all four counties in Hawaii.

These funds are subject to the allotments to be made by the Director of Finance, State of Hawaii pursuant to Chapter 37, Hawaii Revised Statutes.
