Vice-Chair Yukilei Sugimura. >> Zinn Chou and good morning everybody. >> Council Member Tamara Paltin . >> Aloha Kakahiaka, and Kyora kakou, because I'm going to ---- >> OCTOBER 1st through the 10th for my daughter's 8th grade.\r\n\r\nHauiki. >> Council Member Gabe Johnson. >> Zinn Chou, Council Members, community members. Thank you, Chair.\r\n\r\n>> Thank you. >> Council Member Tom Cook? >> Aloha good morning, Xin Chao. There's nobody in the Kihei office currently to give testimony, and ready to go to work. Looking forward to the meeting. >> Council Member Nohelani Uu-Hodgins. >> Good morning everyone.\r\n\r\nXin Chao. >> Council Member Shane Sinenci? >> Aloha Kakahiaka, Chair, and Xin Chao. I'm here at my home office. I'm here by myself. There are no testifiers at the Hana District Office, and Chair, I will have to jump off at 12:30 for another meeting that might need quorum. Thank you.\r\n\r\n>> Oh, okay. Well, we'll try and you know, accommodate you by finishing by then. >> Thank you. >> And Council Chair Alice Lee? >> Xin Chao. Good morning everyone. >> Chair?, you have nine members present, which means you have a quorum to could be duck the business of the Council.\r\nFor the record, I am the County Clerk Moana Lutey, and joining me from te Office of County Clerk are Legislative Division Staff Joy Murashige, Lauren Saldana, Dell Yoshida and Arthur Su Yamuna asisting the Council with order and decomfort I Ryan Martins and joining the meeting from the Office of Council Services is Director David Raatz and legislative Attorney Carla Nagata and from the Department of Corporation Counsel is Corp. Counsel vigoria Takayesu. >> Opening remarks will be provided by Pro Tem Tasha Kama. >> Thank you, Chair, and good morning to my colleagues on the Council, the Staff, and those who are in attendance, either in-person or virtually. The poster in the Mauka elevator of this building states in very large font Aloha Iki, and translated to English means "love one another." Kind of reminds me when I was in church and sprinkled throughout the Sunday school wall were scriptures on plagues and the scriptures would help us remember GOD's promises to us, and now here in our own County Building, I feel that it was a message handed to all of us from on high. I know that at times I am challenged to love others -- it's hard to sit in the Chamber and be a Chair and hear members of our community attack one another, and what should just be policy discussion and we hear one side of the issue and hear other people vilify the other side of that issue and it goes back and forth and back. Recently when we are taking testimony over Bill 9, I felt like I had to rein in the passion, that were expressed by many in the audience because of disruptions for delaying te Committee from getting the work done.\r\n\r\nI felt challenged to love those who were disruptive. I was challenged to those who were clearly expressing hate to another segment of our community and disappointed that some felt detered from giving testimony by the threat of physical violence, and the public revelation of the residential addresses called doxxing, what has happened recently in the Chambers is reflective of the national times we're living in. We're now in a country where civility is getting to be rare. We appear less willing to gve others the benefit of the doubt, and someone says something that we disagree with, and we immediately jump into attack mode. We appear to have lost the ability to end the discussion with willing to agree to disagree. We understand that catching the slings and barbs of the public is something that came with the territory of being an elected official. The public retains the right to voice their disagreement with what we do, and the choices we make on their behalf, but I can always hope that their disagreements could be expressed civilly, and many times I felt disappointed.\r\n\r\nI am hoping that we can somehow return to a time when Aloha was the dominant expression in our state, and in our County. I am hoping that we can find a willingness to agree to disagree. I'm hoping that we can continue to love one another, despite, despite the clear divisions that have been sewn in our community. And so I wanted to read this -- just some -- I wanted to read what tuches my heart a lot of times when I do m readings. What I read, what love is. Love is patience. Love is kind.\r\n\r\nIt does

not envy, it does not boost. It is not proud. It does not dishonor others. It is not self-seeking. It is not easily angered. It keeps no record of wrong doings. Love does not delight in evil, but rejoices with te truth.\r\n\r\nIt always protects, always trusts, always hopes, always perseveres. Love never fails. So for us as we move forward as a Council, and as a community, I pray that we, too, will never fail in our love for one another. Thank you, Chair, for the opportunity for me to share by opening remarks this morning. >> Thank you for those beautiful remarks. Thank you. Members, now please join me in reciting the Pledge of Allegiance.\r\n\r\nI pledge allegiance to the flag of the United States of America, and to the republic for which it stands, one nation under GOD, indivisible, with liberty and justice for all. All right. Thank you. Before we proceed with today's agenda, MAY I please request that everyone keep their microphones muted unless it'sore turnpike to speakment as a reminder testimony must pertain to items on the agenda. MS. Clerk.\r\n\r\n>> Thank you. We'll begin with the presentation of written or oral testimony at this time individuals MAY testify on any of the items on today's agenda. Chair, we'll begin with Eva bloomensteining testifying on Bill 108, and she will be followed by Haloa Dudoit. Good morning, chairs, Members. Eva Blumenstein, Planning program Administrator for Department of Water Supply, testifying on Bill 108 for Intergovernmental Agreement between the Department and te U.S. Geological Survey. We have an ongoing water-resource monitoring program since the 1980s with U.S.G.S.. And we would like to continue this program this year with two new additions: the additional dliverables is rain gulag at Hahn Mana stream in East Maui and phase 1 of the study to develop deep monitor wells in West Maui. The Intergovernmental Agreement for current program was passed by Ordinance 5707 SEPTEMBER 27th Hastyear.\r\n\r\nAnd the notice to proceed was issued on OCTOBER 1st. So this ends the end of the Federal Fiscal Year SEPTEMBER 30, 2025. U.S. Did not have a ready preparesal for the lan Poca deep well and we received the proposal in FEBRUARY 2025 and the Intergovernmental Agreement was passed by Ordinance 5794 on April 21,2025. The joint planning agreement was supposed to be executed in consult MAY. That didn't happen. There was a lot of turnover in the usgs and I was out of the office for most of that time. So that fell through the cracks. That is on me and we're asking for that to start now as originally planned for last year. We do have the total cost agreement is \$321,217 with the Department contributing \$270,558 and U.S.G.S. \$50,659 and we have sufficient funds allocated in our fy'26 budget.\r\n\r\nSo if possible, we ask action to be taken on the floor today to make sure that we have the joint funding agreement executed before it

expires. Ma'alo. Mahalo. >> Questions? Members? Member Paltin. >> Thank you, Chair.\r\n\r\nThank you, MS. Blumenstein for your testimony. I just wanted to clarify the 30-day comment period on the draft ea for the Lani Poca exploratory wells project in Lahaina, Maui ends Monday, September 8th, 2025? >> es, that is not for the monitoring wells that is for development of eventually exploratory, and production wells. >> Oh, that is different wells. >> Yes. >> Lani POKo? >> Yes.\r\n\r\n>> Anyone else? If not, thank you. >> Chair, the next testifier is Haloa Dudoit and if you could let us know what item you are testifying on, follow by the Royal House of Hawai'I. >> Aloha Chair Lee, Vice-Chair Sugimura and Council Members I'm testifying on Bill 98 my name is Haloa Dudoit representing the youth summit program fiscally sponsored by the Boys and Girls Boys and Girls Club of Maui Strong support for 98 which would amend the Fiscal Year 2026 bunt to allocate \$25,000 from the Office of Recovery Program to the Office of the Mayor Administration program for the 2025 youth leadership summit. Excuse me. The supplement will be held Friday, SEPTEMBER 12th, 225 and is youth led youth organized gathering designed it empower or future leaders of Maui Nui. Supplement has four core goals amplify youth voices and local decision-makinging, adress our migration and its impacts on our island's future equipped students with both academy and practical lfe skills and create a youth roadmap for long-term community impact. This appropriation will directly fund transportation both ground and air, audio, visual and sound equipment, as well as travel for panelists and facilitators.\r\n\r\nBy supporting this appropriation you are investing in a space with our youth can meaningful engage with the challenges and opportunities for our County. Connect with peers and mentors and work collectively to define the next-generation of leaders. The capabilities summit is an investment in the criminal caption and resilience of our County. We're grateful for the administrating and the Council thank you for your time and consideration and I'm here for questions. Should you have any. >> Thank you. Questions?\r\n\r\nVice-Chair Sugimura. >> Thank you very much for testifying. Was this planned by the youth for the youth, it seems like the template is for this? >> Yes, this summit is entirely youth led. To give an example we have a internship program, it's a paid intern shall program and this year we have four interns of the part of that program is for them to develop something that is meaningful for them and this year it's the youth summit is something that they wanted. To sat the start of the summer, something they did, they created a survey to send out to their peers. From that survey they used their findings to develop this youth smmit, what the breakout sessions would be, so that it's catered entirely to their peers and the youth.\r\n\r\n>> Excellent. Can somebody let me into the meeting? I can't get in by video, just curious. Thanks. Thank you. >> Pardon me? >> Council Member Kama had her hand up.\r\n\r\n>> Pro Tem Kama. Pro Tem Kama. Where is the volume? Can you read the paper on the screen? She is looking at her phone, I bet. Can somebody call her again, please? >> Can you hear me now, Chair?\r\n\>> Yes. >> Can you hear me now? >> Yes. >> So my question to Haloa was how many students are participating in this event? Thank you, Council Member Kama. So we're expecting a little bit over 200 students to participate in this event. What we're doing is going to the Hgh Schools and open to first-year students at uhmc and the way to sign up is approach their Counselors at the High Schools.\r\n\r\nAll High Schools across Maui County including Moloka'I High School, as well as Lana'I High School to sign up for this summit. >> And when is the summit? >> It's o SEPTEMBER 1th of this year. It's a Friday. >> In a few weeks. >> Yes. >> Okay.\r\n\r\nThank you. Thank you, Chair. >> More questions? Council Member Rawlins-Fernandez? >> Mahalo, Chair. I think I will save this question for when the

item comes up, if it's being requested to take action on the floor today. The question is regarding why it's under the Office of Recovery?\r\n\r\nAnd if MR. Dudoit knows the answer to that? Mahalo. >> We have the Budget Director here. >> Mahalo for your testimony. I hope you are feeling better. >> Thank you, Council Member.\r\n\r\n>> I'm the one that is sick. [Laughter]. >> I had a meeting with him yesterday. He wasn't feeling well. I hope you are feeling better, Chair. I have cough drops in abundance. >> Any more questions? If not, thank you, MR.\r\nDudoit. >> The next testifier is the Royal House of Hawai'I if you could pleat let us know what items you are will be testifying on, followed by Thomas daya. >> Aloha. I will be speaking -- I will be testifying on -- so when it says "County Communication/Committee Report and Resolutions and Ordinances are all items highlighted in blue? >> Yes, you can testify on anything, on the agenda. >> Oh, okay. I will be testifying on Bill 95, Bill 96, Bill 97, Bill 98, Bill 100, Bill 101, Bill 102, Bill 103, Bill 104, Bill 1015, Bill 106, Bill 107, Bill 108, Bill 57 Bill 87, Bill 88, Bill 89, Bill 84 -- I'm testifying and Istand before all of yous an Allodial land tenant and Royal Patent descendant, and heir and resident of Hava Hava, Royal Patent 7447 Halau 3237. And I am asserting that any attempts -- so yeah, attempts to pass bills, permits or titles related to the land in Hawai'I are fundamental flaw and potentially illegal.\r\n\r\nSo every parcel of land in Hawai'I is held under Royal Patent Allodial titles if you haven't known, and patented by the royal government of Hawai'I, and this title lasts forever. And it said it in the tmk paperwork. It shows it in the tmk under legal info and gives you the Royal Patent and who the rightful owners are. And it has been changed recently. So I ask why it's being erased because the info, I'm pretty sure have t show the Royal Patent since the State manipulated our metes and bounds and created their own tmk- which is a crime on an international level, and any efforts to create, like, Land Trust, bills or schemes that conflict the Royal Patents and Allodial titled lands would be a crime on international-level, for example, myself, and many others hven't been contacted. Nobody reached out to any of us, and yeah, these titles are rooted in the constitution of Kamehameha iii, and the laws of the Kingdom of Hawai'I, which supersede any subsequent attempts to alter or undermine them. And it's perplexing to hear testimonies about creating invalid Land Trusts for regular people, when, in fact, the land is held in perpetuity under the Royal Patents Allodial titles for specific 'Ohana.\r\n\r\nThese titled ilked during of Mahele created a clear framework for governance and decision-making regarding the land because the descendants of the Royal Patents and the Allodial landings decide what happens on those lands. So MAY I ask any of these plans that are happening where any of the descendants contacted by right by law? If I MAY ask, because I have no been contacted at all. And that is really crazy. But given the historical and existing legal framework, it's evident that the Native Hawaiian people with the Royal Patent Allodial titles will be the best suited to govern and side what happens on their ancestral lands. After everything that they have lived through and the challenges, and effects of land mismanagement and likely guarantee prioritize sustainable and community-driven solutions, avoiding our right to give out massive evictions. So I demand you and urge you to find each descendant and beneficiary of the policy La Nuis and aka the Royal Patents which are already supposed to be done, but haven't. Because again, I haven't been contacted.\r\n\r\nAnd from the brainwashing and injustices, continuing to this dy, from being taught in school, I just graduated in 2023 and they still brainwashing the people. Businessmen ended the royal and they brainwash you and tell I that the businessmen ended the royals for the

landownership, when in reality and actuality, we're literally the descendants and walking royals with Royal Patent Allodial land titles that belong to us. And lasts forever, no matter what. Please stop erasing -- I don't know why you guys stay reracings Royal Patents and the rp, the Royal Patent and lca, land Commission awards from tmk. Please put that on, because you have manipulated our metes and boundaries of our country and the relationship relationships are the titles to the metes and bonds of this country and the metes and bounds once created metes and bonds can never be changed. And mahalo again for hearing me out and one another one, so the businesses and corporations with big plans that they need hire many large landowners and development target MAY native men and them as puppets to think it's easy money. They continue to business -- continue to lie to themselves by indulging in the benefits of said businesses through invasive alcohol, drugs, social media and the items that distract them from the reality that these issues cannot b ignored more much longer, we're acpising our substances, culture, lifestyle and subjecting our children to disconnection from 'aina.\r\n\r\nBringing more jobs that will not help or benefit the community either over the health of the people, which is corporate slavery that leads to a greater reliance on import which will only lead to illness and disease. Imagine knowing this is the reality fr your children, if nothing is done and then choosing to do nothing about it to prevent any of the participation of genocide happening to my Ppa's kingdom. How dare people develop on highly sake he had sites? To build a cage while using our native rights to develop, and have many exemptions there are cultural sites sites all over for example like wealia 670, where my uncle Mike was never called for all of the -- all cultural site and hasn't een. They just ignored it. It's really crazy, but anyway, I urge the Committee to respect the existing legal framework and recognizing the rights of the Native Hawaiian our lands are established by the Royal Patent Allodial titles. Any aTexass to Nu mine these rights would be a continuation of the injustices that have plagued our island since 1893 and follow Kamehameha 3's law [A-ugz/] Contact the descendants of Royal Patents as needed because I'm pretty sure none of the descendants of Hawai'I have been contacted in regards to this development.\r\n\r\nTo that policy lanui any clear violation of happening on international level being done to my Papa's kingdom and the people of the kingdom and the Kingdom of Hawai'I, and especially Maloofe. >> Thank you. Any questions? Members? If not, thank you very much. Chair, the next testifier is Tomas daya, to be followed by Brian Mick, and if you could please let us know what item you are testifying on. >> Aloha, Kakahiaka.\r\n\r\nMy name is Tomas daya, Chief Executive Officer with the Boys and Girls Club of Maui. I will be testifying on strong support Bill 98 I'm representing the Boys and Girls Club of Maui the fiscal sponsoring of the Ka Pewa youth summit and Bill 98 which would amend the Fiscal Year 2026 budget to allocate \$25,000 from the Office of Recovery Program to the Office of the Mayor. For the Ka Pewa youth leadership. The summit strongly aligns with Boys and Girls Club of Maui and our leadership programming within our doors, as well as through leadership events. We have seen such great impact, these programs have had on our keiki and Opio, and we have seen our members grow into leaders in the clicks and later into the community and workforce. In the past we have had team here on Maui from the Lahaina clubhouse servinging on a nail Steering Committee for a national conference being one of 12 in the world. We have sent several groups over the years to participate in the contributory negligence such as these and have seen the impact that they have had on the youth.\r\nThese very teens who are the future of Maui and equipping them with the skill and expense are invaluable. Our mission at Boys and Girls Club of

Maui is to inspire and enable all young people. Thus our engame in the Ka Pewa youth leadership smmit. We know not every youth comes to a club and us engaging in this will help not on bring our members, but opportunity to other teams across Maui. As always, great future start here. They start with opportunities like the Ka Pewa youth summit and with your support, it's truly an investment in our community. Thank you very much.\r\nIf you have any questions, please let us know. >> Questions, Members? If not, thank you very much. >> Chair, the next testifier is Brian Mick. MR. Mick, if you could please let us know what matter you are testifying on, followed by Lesley Milner . >> [Inaudible] . We're having trouble -- can you stop for a minute? We're having trouble understanding you.\r\n\r\nCome closer to the mic, maybe that will help? Do you have other devices on, by any change? >> No. How is that? >> I hear feedback. There's is feedback somewhere. >> Somebody else is unmuted, I think.\r\nAnd talking when he talks. >> Okay. Let's try again. >> How is that? >> Good. >> Are you able to hear me? >> Yes.\r\n\r\n>> ood morning, Chair Lee. I'm Bian Mick and I'm testifying in support of Bill 87. I'm with the State's Department of Business, Economic Development, and Tourism with Department o Health, Bill 87 authorizes the Mayor to enter ang Intergovernmental Agreement with us for the issuance of disability parking placards. I thank you folks for moving expeditiously on this Bill as I mentioned usually our first reimbursement to the County would be at the end of the 1st quarter. So that is coming up at the end of SEPTEMBER. So we would need to get this executed in time in order to be able to issue that check. But I'm here in case anybody has questions on the agreement. Or parking program more generally.\r\n\r\nThank you. >> Thank you. Questions, Members? Member Johnson. >> Thank you, Chair. Good morning, Brian. Thank you for joining us.\r\n\r\nQuick clarifying question you said it's parking signage for handicapped stalled is it that just or restriping of the paint or anything in addition? >> So, no, just to clarify it's for the issuance of the actual parking permits, the placards and specialized license plates that people use to Park. >> Thank you for that clarification. It was kind of hard to hear you. Thank you very much. Thank you, Chair. >> Any more questions, Members?\r\n\r\nIf not, next to testifier. >> Chair, the next testifier is Budget Director Lesley Milner testifying on bills 96,97 and 98 and followed by our Managing Director, Josiah Nishita. >> Thank you, chair. Aloha, Council Members. Bill 96 is amending Appendix a, part 1 for the Prosecuting Attorney. They have been notified by the State of Hawai'I Department of Attorney General crime prevention and Justice assistance division that they will receive additional funds for the Victim-Witness Program. So we would like to add those in the budget, Bill 97 is fr the Electronic Municipal Market Eergency Management Agency.\r\n\r\nThey received a grant from the hazard mitigation Grant Program. This is phase 1. We do anticipate additional funds for this program, but still waiting to that award. So we wanted to proceed with the phase 1 for the Maui County Countywide wildfire mitigation project, so this is Planning for propertis in high hazard areas to help mitigate any grasses or anything that might be wildfire issues. Bill 98 would be to reduce the Office of Recovery by \$25,000 and move those fundss to the office Office of the Mayor for the youth summit which I think has been very well-spoken by those who will be participating in this and w have also worked with ocs and Vice-Chair's office to submit some proposed fd 1 version for all those bills make something non-substantive corrections that are detailed in the transmittal letters. I also wanted to give a plug for Reso 25-163 for the Maui County Fair permit as you know we're all very excited about it, but I'm sure Managing Drector will speak more to that, but I just wanted to put my bluing in. Thank you, Chair. >>

Ouestions for the Director?\r\n\r\nVice-Chair Sugimura. >> We love to rceive money. Thank you. So on Bill 97 the fema money phase 1. S I always thought that a lot of money came in through the dr, but this is addition to? >> s thank you, Chair. Thank you, Vice-Chair. Yes, this is in addition to the dr funds.\r\n\r\nThis is a separate pot of money. >> Okay, great. Keep it coming. Thank you >> We'll do our best. >> Any other questions? If not, thank you vry much. Next.\r\n\r\n>> Chair, the next testifier is Josiah Nishita, testify on area, 25-163 and Bill 98 and he will be hold in by Wilson Chou. >> Okay. Managing Director? I just saw him a few minutes ago. Okay, next. >> Chair, we'll move on to Wilson Chou. MR.\r\n\r\nChou, if you could let us know please what items will be testifying on. I'm the organizer of ka papeling youth summit in accordance to Bill 98 for us we just wanted to let you know about our story on why we have created this summit. The reason is behind migration as we know Hawai'I I facing a large population of students studying off-island and not really coming bck for the workforce. So by providing this youth summit, we hope to really encourage students and give them equal access opportunities throughout Maui County and be able to obtain the Workforce Development here. So thank you so muchtor all your consideration on our Bill, and we just hope to see this being established. We're looking for questions, if anything that you have in mind. X thank you, any questions, Members?\r\n\r\nThank you very much. MAY we have the next testifier. >> Chair, there's currently no one else signed up to testify. I move to adopt the recommendations in cr 25-47. >> Second. >> Moved by Member Uu-Hodgins, seconded by Member Cook to adopt the recommendation in -- adoncing the Resolution in Committee Report 25-47:discussion, Member Uu-Hodgins thank you, Geb Chair at its meeting of JULY 22, 2025, your Great Committee met to discuss Resolution 25-141, with -- which authorizes settlement of the claim filed on NOVEMBER 13, 2023 in amount of \$62,986.66. One excused Pro Tem Kama, motion carries. S in Clerk s Chair, before you is resolution 25-165 urging the Liquor Control Commission t remove permit requirement for

amusement gaming devices in liquor-licensed establishments. >> Member Uu-Hodgins. >> This one is definitely mine.\r\n\r\nI move to adopt resolution 25-165. >> Second. >> Moved by Member Uu-Hodgins, seconded by Member Cook to adopt resolution 25-165. Discussion Member Uu-Hodgins. >> Thank you, Chair. And thank you, members. This has been a little pet project of mine. So resolution 25-165 urges the Maui County Liquor Control Commission to amend Section 8-101-27 (A4) Of rules of the gverning and manufacturing and sale of intoxicating liquor by removaling the permit requirement for installation of a gaming device on the premises for liquor licensee. The Resolution, authorizes the Council Chair -- that is you.\r\n\r\nThank you to submit a petition on behalf of the Council to seek to amend the Section that won't rename again the rules of the complication and to take other reasonable and appropriate action to support the Council's position a copy of the ptition can be found. The current permit process application process places an onerous burden on the businesses seeking to install legal non-gamecocking devices on licensee premises and thus hinders the abilitying of businesses to offer a wide array of ent option options that attract customers having less regulation. Devices like this would result in fun, obviously and greater entertainment amusement options for County residents which in turn would support local businesses and stimulate the economic growth of the County. Have I some little personal things to add. Or liquor rules are slightly arckiac and so the Liquor Commission is updating them now as we speak. So it's good timing that we're request for them to consider this. I have been working with the liquor Director as well for the past few years, but especially now in the last few months to figure out something we can do to mve this forward.\r\n\r\nI don't know about you folks, but when I travel with my family, this is something we normally do at night or during the day just to hang out. We all participate in games I personally really like air hockey. I know that is a little surprising, but me and my husband get really competitive. But it's really fun. It's fun for everybody and I'm excited for the Liquor Commission and the liquor Department to update their rules and to have places that k accommodate family fun like this. So I'm quite excited. So we could have one in hotel in west Maui, it's the valley Alley, which is really small.\r\n\r\nIt's very far way perfect majority of our local residents and it's quite expensive. So I'm excited for somebody to hopefully do this and provide entertainment for a large family like mine and like others. So at this moment I ask Members' support and happy to answer questions if you folks have any. >> Member Johnson. It's a good pet project. The term she used is "archaic." I take it a step further and call it like a footloose carbon dioxide of County where we just abandon everything that is scary and fun and anti-fun. I'm not a fan of that.\r\n\r\nSo thanks for thinking about that. So who thought you would need a permit for a videogame wile everybody sits at the bar on their cell phone playing video games anyway. You know at least when you play pool hockey or whatever air hockey you are doing that with somebody else, whereas, you are sitting on your phone and not intering aing with anybody. So boy, commonsense legislation here, Council Member. Thank you. >> Thank you, Chair. >> Thank you.\r\n\r\nAnd just for clarification, what do I have to do with the petition or something? You are looking at the person who doesn't drink or go to bars or anything like that. But I'll be happy to help you. >> Because we cannot tell the Liquor Commission what to do, they are semiautonomous, we have to send them an urging Reso and to petition them to change the rules. >> Okay. >> Technically a petting petition could come from anybody, but it's quite expensoff and quite difficult for somebody else to do while they are establishing their business so if comes from us, we don't. I don't. None of us have.

I don't think an Arcade that we're trying to permit, so it gives some playing ground and gives them a place to have that conversation without somebody who I going to financially benefit from it right in front of their face.\r\n\r\nPet Hanano helped me write this, so I'm sure he will help you fill it out. >> Thank you so much. >> Thank you. So this is just work that has already been completed and they are just finishing up the paper work on. And this motion is necessary in order for that paperwork and the payout to be complete. I respectfully ask for the Members' support of this motion.\r\n\r\n>> Any more discussion? Vice-Chair Sugimura. >> Important work. Thank you very much, Member Rawlins-Fernandez, for the Moloka'I community. And I would like to recommend that further discussion on this, because I think the funds, which was half a million dollars, which was appropriated JUNE 30, 2021 to JULY 1, 2023 has expired and the request for extension -- I don't know if it was processed through Office of Council services? So I'm not even sure if this grant is still available, but I would like to make sure that this does happen properly. I believe at this point there is a \$250,000 request for payment of which is-if it's \$500,000, and this is trying to make that whole for the 250, with the leftover.\r\n\r\nBut I think the grant period has expired. So I would like to propose tat we do this correctly so that Moloka'I and Member Rawlins-Fernandez can have her money as she is requesting and it be discussed further. So it would be good to have that discussion. >> Chair, I would like to correct the record or state for the record that it's not my money -- >> Yes. >> It's not coming to me and my account. This is to sustainable Moloka'I. I'm not employed by them or have any financial benefit. >> I stand corrected.\r\n\r\nI don't mean you, I mean your island. >> Yes, but you said it will come to me. Chair, the work has already been done. The climate change plan that we requested happened already has been completed and submitted. This is just paperwork issue. I don't know what we would accomplish in Committee by dragging this out further? By making sure that this gets done appropriately, like that is why all the checks and balances are in place in the administration with finance.\r\n\r\nThis was a request from the Finance Department. I don't know what you would accomplish in Committee by taking it to Committee and talking about what I'm talking about right now? >> Mute that person. Any more --Member Uu-Hodgins? >> Thank you, Chair. This question can be answered by anybody, if not Member Rawlins-Fernandez. But I see it's coming out of Council's budget.\r\n\r\nCan you just explain why? >> Sure. Sure. Okay. So the initial \$500,000 was for the first of the Countywide initiative of doing climate change and sa-level rise. That grant was put under ocs. >> Okay.\r\n\r\n>> Like four years ago

or something. I think it was 2019-2020 timeframe, and the pandemic happened, and then the plan was for the meetings to be done in-person. So that kind of got dragged out, because 2020, I don't have to remind of you what happened then. Anyway, so working through all of that, getting the plan done, you know? Followed all the deliverables, but the funding itself, the \$500,000 was under ocs and ocs grant. And then there was a separate \$50,000 request for that same project for additional engineering reports. >> Okay.\r\n\r\n>> And that was approved, and then there was transition on, I think both sides, ocs side and in Sustainable Moloka'I with leadership and Staff, so there was some miscommunication at some point, which is why it's kind of dragging on and why it's under ocs. >> So the remaining \$200,000 that was brought up, this is the remaining \$50,000 of that for the engineering report. >> Okay. Is this a placing where we can review the sea-level Rice plans and engineering reports and all of this stuff? Or how are we going to receive that? >> I can take it up in my Committee. >> Oh, that would be great.\r\n\r\n>> If you want to attend. >> Yes. Because this is something that we're proud of. I think we presented to the community -- it wasn't completed -- I think you were on the Council by the time it was completed. >> Okay. >> And then it was presented to the Moloka'I community in its final report. >> Was it only for Moloka'I, or is it --? >> Yes, Yes, yes.\r\n\r\nThe grant itself was like Countywide climate change plan starting with Moloka'I, something like super long and annoying like that -- sorry, that was my fault. Moloka'I was supposed to be the first of all of the Districts, but no other District has taken it up since. >> Thank you. I can email you a copy, too, but I would love to have it in my Committee. I have been wanting that, the transitions of the organization. >> Member Cook, and then Vice-Chair Sugimura. >> Thank you, Chair.\r\n\r\nSo for clarity, so I understand, what will these funds be used for? Is it to pay existing bills? And who are the existing bills paid to? >> Mahalo, Chair. Mahalo, Member Cook for the question the \$50,000 was for the additional engineering report that I mentioned to Member Uu-Hodgins. Sustainacle Moloka'I as you know, our County grant process is that the grantee pays out first, and then gets reimbursed by the County; right? And so they have to front the money.\r\n\r\nSo Sustainable Moloka'I paid out the engineering firm for doing the report that they were requested to do. And then sustain able Moloka'I submitted the invice and its final report to the County for reem Burt of it. >> For clarification, but they haven't been paid and how long ago was that submitted? >> Yes. They have not been find this final \$50,000. This is something was working on from last year. So yeah, yeah, I would love for this to be done. >> Vice-Chair Sugimura.\r\n\r\n>> Important. So the reason why that I have questions is that based upon a request from the Department of Finance purchasing division contract, I don't see an approval on the form that was submitted by David Raatz, and time of performance is 7/2/23 to 7/30 -- JUNE 30th, 2024, which is expired. It doesn't look like it ws processed. >> Maybe David can clear that up. >> Okay, David. >> MR. Raatz.\r\n\r\n>> Thank you, Chair. Thank you for the questions, and discussion. We have been working with finance, and Corp. Counsel on this Bill that has been presented today. I apologize for the delay.
