Aloha Chair White, Vice-Chair Carroll and Members of the Council:

Pacific Resource Partnership (PRP) is a not-for-profit organization that represents the Hawaii Regional Council of Carpenters, the largest construction union in the state, and more than 240 of Hawaii's top contractors. Through this unique partnership, PRP has become an influential voice for responsible construction and an advocate for creating a stronger, more sustainable Hawaii in a way that promotes a vibrant economy, creates jobs, and enhances the quality of life for all residents.

We respectfully oppose the proposed bill establishing a new Chapter 20.40 Maui County Code, declaring a moratorium on sand mining of central Maui inland sand.

The sand mining moratorium could delay and potentially halt housing development in central Maui and in turn delay the County of Maui and the State of Hawaii's goals and objectives of increasing the supply of desperately needed housing to meet the needs of our growing population.

The moratorium is not needed as an environmental review process already exists - the State Historic Preservation Division of Department of Land and Natural Resources identifies significant historic properties in project areas and develops and executes plans to handle impacts to the significant historic properties in the public interest. The review process supports the policy of Chapter 6E, HRS, to preserve, restore, and maintain historic properties for future generations.

I am speaking out against Mr. White's proposed Amendment to 2.08.050.

This amendment is Nixonesque. It may be unlawful legislation, as it seeks to deprive each elected representative the ability to employ their own staff, not based upon a set of genuine qualifications, but based upon the prevailing majority of the Council at any time. As such, it lacks a reasonably objective legislative intent, except to cause the majority of any council the ability to terminate staff members of a fellow councilmember, at will, without just cause, and, perhaps, for an improper purpose.

It also seems to come at a time, when there are allegations of a hostile workplace environment created by none other than the sponsor of this legislation, Mike White.

It appears that the motivation for this amendment is clearly to terminate particular individual(s) presently working for particular councilmember(s). So, in other words, the intent of the amendment is to misuse the legislative process to advance a personal agenda (held perhaps by more than one councilmember). Such agenda seems to be the result of an executive assistant calling to account, various manner of wrongdoing, behind the scenes at the County Council; ie. a form of whistleblowing, as it were.

Legislation should not be misused in such manner. In the Courts the term for this is abuse of process. I believe that here too, this legislation constitutes an abuse of process by Mr. White. Doing what would otherwise be a legitimate act of governing, for an improper purpose.

Not widely known, Mr. White is also the Chief Procurement Officer for the Council of Maui. He has also failed to respond, at all, to reports of a significant procurement violation by the Department of The Corporation Council which has resulted in the continued cover-up of massive fraud perpetuated by County government in collusion with developers and their agents, on the people of Maui County. So, it is no surprise to me, that he would engage in such an abuse of the legislative process for an improper purpose.

Therefore, I am in support of a different Amendment, drafted by a former executive assistant to a former Councilmember. (see attached Amendment) This Amendment of the same legislation, would, and instead, advance the public interest by insuring that there be a staff member of each councilmember, with the

necessary expertise which pertained to the committee for which that councilmember was Chair. Thus, enabling the county government, through our elected officials to fulfill their duties and responsibilities more competently, effectively and efficiently.

This is an objectively reasonable amendment, as opposed to Mr. White's unreasonable request, which is clearly politically motivated. Politicization of the hiring and termination of staff which serve elected councilmembers is neither constructive or productive in the efficient functioning of government. It also lacks integrity and erodes the public trust.

A. Provide for analysis of issues and concerns of citizens by and educated Council staff employee who can interpret existing ordinances to insure the Administration is acting in accordance with the stated language and intent.

AN AMENDMENT TO A PROPOSED BILL FOR AN ORDINANCE TO AMEND SECTION
2.08.050, MAUI COUNTY CODE, PERTAINING TO LEGISLATIVE BRANCH ORGANIZATION

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 2.08.050, Maul County Code, is amended by amending subsection A to read as follows:

"A. The council may provide for legislative personnel who are not members of the council services staff.

1. Council executive assistants shall serve under a council member, and shall have terms of employment that coincide with the term of the supervising council member unless sooner terminated by the council member having direct supervision.

2. Council aides shall serve under the council chair and shall have terms of employment that coincide with the term of the council chair unless sooner terminated by the Council chair."

3. Council member's staff shall include a part time or full time individual who has professional or educational background in their assigned Committee. Within 90 days of assignment of the chair of a Council Committee, Council Member shall submit to the Chair of the Council the qualifications of the staff member being retained for employment.

SECTION 2. New material is underscored. In printing this bill, the County Clerk need not include the underscoring.

SECTION 3. This ordinance shall take effect upon its approval.

We are a confederation of fifty-eight (58) Hawaiian Civic Clubs located throughout the State of Hawai'i and in the States of Alaska, California, Colorado, Illinois, Nevada, Utah, Virginia, Washington State, Tennessee and Texas. Our mission is to "Serve with pono in advocacy of culture, health, economic development, education, social welfare and nationhood."

This year, during the first week of November, we convened the 58th Association of Hawaiian Civic Clubs Convention in Seattle, Washington. This resolution saw clear passage to the plenary floor where it was unanimously passed. For Hawaiian's, there is no distinction between our family or a hand full of sand. Sand was not always sand. If you want to be scientific about it, its the product of decomposition – of bigger stones, rocks, mountains, coral and other calcified objects, like bones.

The resolution was co-authored by Hawaiian Civic Club of Honolulu and its member, Benton Kealii Pang, who has Maui roots. It reads:

WHEREAS, Sand mining or beach sand mining is a practice that is used to extract sand, mainly through an open pit, however, sand is also mined from beaches, inland dunes and dredged from ocean beds and river beds.

WHEREAS, It is often used in manufacturing as an abrasive, for example, and it is used to make concrete; and

WHEREAS, millions of tons of sand from Central Maui dunes have been mined and shipped off the island since the mid-1980's; and

WHEREAS, the Central Maui Sand Dunes stretching from Kahului Harbor to Waikapū is also known as the Pu'u One Sand Dunes; and

WHEREAS, Maui chief Kahekili met the invading warriors of chief Kalani'ōpu'u of Hawai'i at the sandhills of Kama'oma'o... between Wailuku and Waikapū" and this 1776 Battle of Kakanilua (Ahulau Ka Pi'ipi'i i Kakanilua) occurred near the sands dunes of Waikapū killing 800 warriors; and

WHEREAS, the Wailuku-Kahului Community Plan has determined the Pu'u One Sand Dune Formation as a cultural resource and wahi pana; and

WHEREAS, a 2006 study of the Pu'u One Dunes, informed Maui County that current mining/shipping rates stated the resource would be depleted by 2011; and

WHEREAS, shared ownership interests connected to Maui Lani developer Bill Mills, excavation company Honolulu Construction & Draying Co. (HC&D), the sand barge Quinault, Pohaku Paa and Ameron (dba HC&D) sold \$30 million worth of cement in just one year alone to the Honolulu rail project; and

WHEREAS, according to the Maui County Planning Director, Maui Lani and HC&D have properly been issued grading permits, but because the excavation and exportation of high quality sand for making concrete and other purposes meets the definition of "resource extraction"; and

WHEREAS, resource extraction may require either a special use permit or a conditional use permit, neither of which are currently held by Maui Lani or its partners; and

WHEREAS, the county had issued notice to Maui Lani to pause and apply for more permits; and

WHEREAS, a lawsuit brought by Mālama Kakanilua was filed in Environmental Court on August 2, 2017, to halt activity at the Maui Lani site saying the mining disrupts Hawaiian burials, violates county grading permits, and county zoning laws (Civil no. 17-1-03113); and

WHEREAS, the Maui Lani Partners Archaeological Monitoring Plan that has been approved by the State Historic Preservation Division (SHPD) provides "all grading activities will be monitored full time... [n]o sand will be excavated directly out of the ground and loaded into trucks[s]" and the protocol requires "[o]ne archaeological monitor per piece of ground disturbing equipment."; and

WHEREAS, in 2016, Maui Lani reported at least three inadvertent discoveries of burials to the SHPD; and

WHEREAS, six temporary burial sites reported to SHPD by Maui Lani were considered “extremely culturally sensitive”; and

WHEREAS, Office of Hawaiian Affairs (OHA) is calling for all grading to stop immediately to give county and state regulators time to sort out zoning, permits and iwi preservation practices; and

WHEREAS, in April 2017, Maui Mayor Alan Arakawa called for a sand export moratorium; and

NOW, THEREFORE, BE IT RESOLVED, by the Association of Hawaiian Civic Clubs at its 58th Annual Convention in Seattle, Washington, in the malama of ‘Ikuwā and the rising of Māhealani, this 4th day of November 2017, urging the Maui County Council to prohibit the resource extraction of sand from the Pu‘u One Sand Dunes; and

BE IT FURTHER RESOLVED, that the Honolulu City Council prohibit the importation of sand from the Central Maui Sand Dunes for the Honolulu Rail Project; and

BE IT FURTHER RESOLVED, that a certified copy of this resolution be transmitted to Maui-Lanai Burial Council, Mālama Kakanilua, Maui County Council Chair, Honolulu City Council Chair, Honolulu Authority for Rapid Transportation, Executive Director, as well as the Governor of the State of Hawai‘i, President of the State Senate, Speaker of the State House of Representatives, Chair of the State Senate Committee on Hawaiian Affairs, Chair of the State House Committee on Ocean, Marine Resources, & Hawaiian Affairs, Chair of the Board of Trustees of the Office of Hawaiian Affairs, all County Mayors.

Council member Yuki Lei Sugimura is proposing a resolution urging the State to protect iwi kupuna at this December 1 Council meeting. Chapter 6E, Hawaii Revised Statutes, mandates that at any site, other than an actively used cemetery, where human skeletal remains are discovered to be buried and appear to be over fifty years old, the remains and their associated burial goods shall not be moved without recommendation from the respective island Burial Council and approval of the DLNR’s State Historic Preservation Division.

The proposed resolution urges timely review and ongoing oversight of archeological inventory surveys, archeological monitoring plans, and archeological preservation plans, including requiring site inspections during land alteration activities to ensure compliance.

I would like to extend my deepest aloha to Mālama Kakanilua, Clare Apana and her ‘ohana who has worked tirelessly to breath life back into this wahi pana.

I support agenda items CC 17-472, CC 17-473 for the ban of sale of toxic sunscreens containing oxybenzone, octinoxate, and similar endocrine-disruption chemicals that are harmful to our marine life (and our own bodies too). I learned from volunteering at Ahihi Kina'u Natural Area Reserve that just one drop of any of these chemicals is enough to inhibit reproduction of coral in the equivalent of 6 1/2 olympic swimming pools of water. They are so toxic that 62 parts per TRILLION is all it takes to do permanent damage. I learned that 1 barrel (55 gallons) of sunscreen is washed into the ocean every day, including through shower water washing it off that is not treated to remove the chemicals. I learned that Big Beach has 800 PPT, Kaanapali has 4000 PPT, and Waikiki has 15,000 PPT of these chemicals in water samples, all of which are way more than is required to kill our coral reefs, and thereby the fish and every other creature that lives in them. And I learned that these chemicals are concentrated as they go up the food chain into larger predators. No wonder our reefs are dying and fish are disappearing.

Please act now to ban these chemicals before it is too late!

The 2017 Legislative session for the Maui County Council began in controversy, chaos ensued and given the intensity of the divisiveness the members of the Maui County Council attempted to stabilize the situation by the adopting Resolution 17-4 on January 2, 2017, Rules of Council. Those voting "Aye" were Council Members Bob Carroll, Stacy Crivello, Riki Hokama, Yuki Lei Sugimura and Mike White. Those voting "Nay" were Council Members Don Guzman, Alika Atay, Elle Cochran and Kelly King.

By letter dated November 21, 2017 Maui County Council Chair Mike White proposes “A Bill For An Ordinance To Amend Section 2.08.050, Maui County Code, Pertaining To Legislative Branch Organization.”

Section 2.08.050 of the Maui County Code was last amended in 2010.

The Rules of Council contains and covers full-time Council Executive Assistants and Council aides, similarly as in Section 2.08.050. Rules of Council, January 2, 2017, being more recent, should govern. Noted, Council Chair White voted in the majority to adopt Resolution 17-4.

Council Chair White's “change of heart” from January 2, 2017 [Adoption of Resolution 17-4] to November 21, 2017 proposing a bill to essentially “override” Resolution 17-4 requires in-depth and thorough investigation.

The news article Maui Council Chair Mike White Seeks New Dictatorial Powers Friday 9 a.m. Hearing to Vote on New Law Empowering the Ruling Gang of Five to Fire Staffers Hired by Independent Council Members¹, the tone and the timbre of the voices of the Maui County citizenry, heightened emotions, expressions of anger and frustration over the transparency, honesty, truthfulness and integrity of the governmental process is a déjà vu to the beginning of the 2017 Legislative session.

In this regard, thorough and in-depth inquiry is mandated. In particular, whether there is an intentional failure to exercise duties and responsibilities as set forth in the Charter of the County of Maui as described in Maui County Code § 1.12.020.

TITLE 2 - ADMINISTRATION AND PERSONNEL
CHAPTER 2.08 - COUNTY COUNCIL SERVICES
ARTICLE 2. - STAFF
§ 2.08.050 - LEGISLATIVE BRANCH ORGANIZATION

A. The council may provide for legislative personnel who are not members of the council services staff.

1. Council executive assistants shall serve under a council member, and shall have terms of employment that coincide with the term of the supervising council member unless sooner terminated by the council member having direct supervision.

2. Council aides shall serve under the council chair, and shall have terms of employment that coincide with the term of the council unless sooner terminated.

B. Unless otherwise provided by law, all legislative positions shall be subject to a pay plan established by ordinance, as well as the general authority of the council chair as chief administrative officer of the legislative branch.

Rule 6. Officers and Their Duties

A. Council Chair. The Chair shall be the presiding officer and the chief administrative officer of the Council. In the absence or disability of the Chair, the Vice-Chair shall act as the presiding officer and chief administrative officer. The Council shall appoint a President Officer Pro Tempore from its own members in the event of the absence or disability of both the Chair and Vice-Chair.

It shall be the duty of the Chair, in addition to those duties prescribed by law to:

2. Appoint all employees of the Council, except that full-time appointments shall be approved by the Council; provided, however, that appointment of full-time Council executive assistants and Council aides need not be approved by the Council.

CHAPTER 1.12 - GENERAL PENALTY

§ 1.12.010 - Penalty where no penalty provided—Code.

In any case where there shall be a violation of any of the criminal provisions of this code for which no penalty is provided, the person violating the same shall be subject to a fine of not more than \$100 for each offense.

Any person who intentionally fails to exercise his duties and responsibilities as set forth in the charter of the county of Maui or who violates any prohibition provided for therein, for which no penalty is provided, shall be punished by a fine of not more than \$1,000 or by imprisonment for a term not to exceed one year, or both.
