Legislation: Proposed resolution relating to the appointment of Kaulana Mossman to the Liquor Control Commission for the County of Maui, attached to County Communication 19-245.

Description: Amend resolution to disapprove the appointment of Kaulana Mossman to the Liquor Control Commission for the County of Maui, for a term expiring on March 31, 2023, due to receipt of the Mayor's correspondence dated June 4, 2019, requesting Mr. Mossman's name be withdrawn from consideration due to personal circumstances.

RELATING TO THE APPOINTMENT OF KAULANA MOSSMAN TO THE LIQUOR CONTROL COMMISSION FOR THE COUNTY OF MAUI

WHEREAS, by correspondence dated April 15, 2019, Mayor Michael P. Victorino notified the Council that he nominated Kaulana Mossman to the Liquor Control Commission for the County of Maui for a term expiring March 31, 2023, to fill a vacancy replacing Jonathan Todd, pursuant to Sections 8-13.2 and 13-2, Revised Charter of the County of Maui (1983), as amended, ("Charter"); and

WHEREAS, Section 13-2, Charter, requires the Mayor's nominee to be approved by the Council; and

WHEREAS, Charter Section 13-2(17), requires the Council to approve or disapprove the nomination within sixty days after the Mayor submits the name of the nominee to the Council because of the death, resignation, or removal of a member; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it ~~approves~~^{disapproves} the appointment of Kaulana Mossman to serve on the Liquor Control Commission for the County of Maui for a term expiring March 31, 2023; and
2. That the Council expresses its gratitude and appreciation to Kaulana Mossman for his willingness to be considered for public service and actively participate in County government; and
3. That certified copies of this Resolution be transmitted to the Mayor, the Managing Director, and the Corporation Counsel.
