A BILL FOR AN ORDINANCE AMENDING  
THE FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI,  
OFFICE OF THE MAYOR, ECONOMIC DEVELOPMENT PROGRAM,  
GRANTS AND DISBURSEMENTS FOR BUSINESS DEVELOPMENT  
AND TECHNOLOGY, KAHULUI ECONOMIC DEVELOPMENT,  
ENVIRONMENTAL, AND CULTURAL PROGRAMS, HALAU HULA KAULUOKALA, INC.  
AND HALAU KEKUAOKALA'AU'ALA'ILIAHI, INC.

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5657, Bill No. 60, CD1, FD2 (2024), as amended "Fiscal Year 2025 Budget", Section 3.B.12.c.(2).(vii), Office of the Mayor, Economic Development Program, Grants and disbursements for business development and technology, Kahului Economic Development, Environmental, and Cultural Programs, is amended to delete the condition for Kaahumanu Society, delete the condition for Maui High Band Booster Club, and add new conditional language for Hālau Hula Kauluokalā in the amount of \$15,000, and Halau Kekuaokala 'au 'ala 'iliahi in the amount of \$15,000, to read as follows:
