AFFORDABLE HOUSING FUND (BF-173)**

The Budget and Finance Committee is in receipt of County Communication 18-347, relating to proposed amendments to the Fiscal Year 2019 Budget, as it pertains to Part II, Special Purpose Revenues – Schedule of Revolving/Special Funds for Fiscal Year 2019, Affordable Housing Fund. The proposed amendment would appropriate \$70,000 each for a feasibility study of the following: 1) 5.752 acres identified as TMKs: 3-9-038:026, 2-1- 008:046, and 2-1-008:113 and located off Kilohana Drive, Kihei, Maui; 2) 3.93 acres identified as TMKs: 3-9-002:102, 3-9-002:103, and 3-9-002:104 and located on East Kapu Place, Kihei, Maui; and 3) 4.02 acres identified as TMK: 4- 4-001:106 and located in Honokowai, West Maui.

May I please request you provide the following information for each of the proposed sites:

- a. A map of the parcel.
- b. Indicate whether each parcel is owned by the County? If the parcel is not owned by the County, provide the current ownership of the parcel and explain the reason for doing a feasibility study.
- c. Indicate the zoning and community plan designation of each parcel. Also, indicate whether the parcel is within a Special Management Area.
