<a href="#">HB1856 HD1</a>	RELATING TO SEA LEVEL RISE.	Requires the Hawaii climate change mitigation and adaptation commission, in collaboration with the office of planning CZM program, to conduct certain activities to address the impacts of sea level rise and report to the legislature before the 2022 regular session. Appropriates funds for the commission's activities and extends the lapse date to June 30, 2022. Effective 7/1/2050. (HD1)
<a href="#">HB1878 HD1</a>	RELATING TO REAL PROPERTY TRANSACTIONS.	Requires that mandatory seller disclosures in real estate transactions include identification of residential real properties lying within the sea level rise exposure area as designated by the Hawaii climate change mitigation and adaptation commission or its successor. Effective 12/31/2050. (HD1)
<a href="#">HB2590 HD2</a>	RELATING TO AUTONOMOUS VEHICLES.	Establishes within DOT a two-year autonomous vehicles testing pilot program. Requires report to the legislature. Appropriates funds. Effective 7/1/2050. Sunsets 6/30/2022. (HD2)
<a href="#">HB2462 HD1</a>	RELATING TO ELECTRIC VEHICLES.	Establishes an income tax credit of up to \$2,500 per new electric vehicle that costs up to \$50,000. Sunsets on 12/31/2028. Effective 7/1/2050. (HD1)
<a href="#">HB2699 HD2</a>	RELATING TO THE ENVIRONMENT.	Establishes clean ground transportation goals for state agencies on a staggered basis until achieving a 100 per cent light-duty motor vehicle clean fleet by 12/31/2035, and for all light-duty motor vehicles in the State by 12/31/2045. Effective 7/1/2050. (HD2)
<a href="#">HB2701 HD1</a>	RELATING TO THE ENVIRONMENT.	Requires agencies allotted a portion of the environmental response, energy, and food security tax to consider actions in achieving the zero emissions clean economy target and climate change resilience. Requires these agencies to report on how expenditures from these special funds support achieving the zero emissions clean economy target and climate change resilience. Effective 7/1/2050. (HD1)
<a href="#">SB2060 SD2</a>	RELATING TO COASTAL ZONE MANAGEMENT.	Amends coastal zone management laws to further protect against impacts of sea level rise and coastal erosion. Requires the Climate Change Mitigation and Adaptation Commission to submit a proposal for a State of Hawaii supplemental insurance program for properties within the State subject to climate change impacts to the Legislature prior to the Regular Session of 2021. Effective 7/1/2050. (SD2)
<a href="#">SB2162 SD2</a>	RELATING TO SEA LEVEL RISE.	Requires the Hawaii Climate Change Mitigation and Adaptation Commission to consider and make specific recommendations on sea level rise policies. Appropriates funds. Effective 7/1/2050. (SD2)
<a href="#">SB2381 SD2</a>	RELATING TO SHORELINE SETBACKS.	Establishes greater shoreline setback requirements. Effective 12/31/33. (SD2)
<a href="#">SB2670 SD1</a>	RELATING TO REAL PROPERTY TRANSACTIONS.	Requires a vulnerable coastal property purchaser statement to be executed by the purchaser or transferee with the sale or transfer of vulnerable coastal real estate. Effective 12/31/33. (SD1)
<a href="#">SB2671 SD2</a>	RELATING TO REAL PROPERTY TRANSACTIONS.	Requires that mandatory seller disclosures in real estate transactions include identification of residential real properties lying within the sea level rise exposure area. Effective 11/1/2020. (SD2)
<a href="#">SB2683 SD2</a>	RELATING TO SEA LEVEL RISE.	Requires the Hawaii Climate Change Mitigation and Adaptation Commission to further address and make recommendations regarding sea level rise. Appropriates funds. Effective 7/1/2050. (SD2)
<a href="#">SB3099 SD2</a>	RELATING TO CLIMATE CHANGE.	Implements the recommendations of the Hawai'i Sea Level Rise Vulnerability and Adaptation Report issued by the Hawaii Climate Change Mitigation and Adaptation Commission. Makes appropriations. Effective 7/1/2050. (SD2)
<a href="#">SB3100 SD2</a>	RELATING TO SUSTAINABLE DEVELOPMENT GOALS.	Codifies sustainable development goals based on the United Nations' Sustainable Development Goals and indicators. Effective 7/1/2050. (SD2)
<a href="#">SB3150 SD2</a>	RELATING TO TAXATION.	Amends the environmental response, energy, and food security tax to address carbon emissions. Increases the tax rate to effectively set a price of an unspecified amount per metric ton of carbon dioxide emissions in 2021. Incrementally increases the tax rate over time so that, in 2030, the tax rate shall be equivalent to a carbon price of an unspecified amount per metric ton of carbon emissions. Establishes a refundable tax credit for lower-income individuals. Effective 7/1/2050. Tax credit applies to taxable years beginning after 12/31/2021. (SD2)
