



BILL NO. _____ (2017)

A BILL FOR AN ORDINANCE AMENDING SECTION 13.16.040,
MAUI COUNTY CODE, RELATING TO THE
WAIIEHU MUNICIPAL GOLF COURSE SPECIAL FUND

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Section 13.16.040, Maui County Code, is amended to read
as follows:

“13.16.040 Golf course special fund. The proceeds from playing fees, tournament fees, club no-show fees, replacement card fees, rental income, and fees from golf course concessions shall be deposited into a golf course special fund. These proceeds shall be used for the operation, maintenance, master plan for and timely improvement of the golf course], to the end that the golf course shall be self-supporting.], including utilities and equipment, but shall not be used for salaries or other employment costs, fringe benefits, or administrative overhead costs. [No moneys from the general fund shall be expended for these purposes, except that the] The council may supplement these proceeds by specific appropriations to the golf course special fund.”

SECTION 2. Material to be repealed is bracketed. New material is underscored. In printing this bill, the County Clerk need not include the brackets, the bracketed material, or the underscoring.

SECTION 3. This ordinance shall take effect upon on July 1, 2018.
