

On behalf of the Department of Housing and Human Concerns, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, APPENDIX A, PART I, DEPARTMENT OF HOUSING AND HUMAN CONCERNS."

The purpose of the proposed bill is to add a new grant under the Department of Housing and Human Concerns entitled "American Rescue Plan Act of 2021 – Emergency Rental Assistance Program #2 (ERA #2)" in the amount of \$322,248.

To date, the State of Hawai'i has provided \$15,710,000 in ERA #2 Funds to the County of Maui. The State has determined that there is an additional

\$322,248 available for appropriation to the County, making the total allocation \$16,032,248.

ERA #2 funds are to be used to provide financial assistance and housing stability to rental households where one or more individuals has qualified for unemployment benefits or experienced a reduction in household income, incurred significant costs, or experienced other financial hardship during or due, directly or indirectly, to the coronavirus pandemic; one or more individuals within the household can demonstrate a risk of experiencing homelessness or housing instability; and the household is a low-income family as defined in section 3(b) of the United States Housing Act of 1937 (42 U.S.C. 1437a(b)).
