<u>Description:</u> The Committee is in receipt of the following:

- 1. Bill 111 (2024), entitled "A BILL FOR AN ORDINANCE AMENDING TITLE 9, MAUI COUNTY CODE, TO ESTABLISH PROCEDURES FOR THE REMOVAL AND STORAGE OF PERSONAL PROPERTY IN PUBLIC PLACES AND A RIGHT TO SHELTER." Bill 111's purpose is to provide the procedures to compassionately relocate people when necessary, including offering access to services and storage of personal property.
- 2.
