### **DOH Needs Assessment**

Survey of 565 wildfire-impacted residents

#### **Greatest Needs**

- 1. Financial recovery (26%)
- 2. Permanent residence (24%)
- 3. Finding employment (9%)

### **Impact on Mental Health**

- 41% reported a decline in a household member's mental health.
- 80% of surveyed households felt that they could access mental healthcare if they need it.

## **Immediate Support**

### **Wellness Navigators**

Wellness Navigators go door-to-door at the hotels housing individuals and families impacted by the Maui wildfires to offer support.

If an individual needs additional assistance, the wellness navigator will connect the individual with a higher level of support.

#### **Arts & Healing Activities**

DOH partnered with the Maui Arts & Cultural Center to provide arts and healing activities, held weekly in December at the Royal Lahaina Hotel.

## **Crisis Counseling Program**

- CCP helps individuals and communities recover through community outreach and access to mental health services.
- The CCP offers services to disaster survivors in their homes, shelters, temporary living sites, or houses of worship. CCP services include:
  - Basic supportive or educational contact
  - Community networking and support
  - Assessments, referrals, and resources
  - Development and distribution of educational materials

- **Total Funding:** \$684,170

### **SERG Grant – Resiliency Center**

- DOH received funding from SAMHSA to establish a Resiliency Center or Centers to support long-term behavioral health services.
- The Resiliency Center will create and provide a continuum of culturally appropriate behavioral health services that address prevention to acute crisis response and intervention.
- The community will determine its structure (one center or multiple smaller centers) and services.
   Community engagement and planning is integral in developing community resiliency.

## **Navigating the Topic of Suicide**


- Suicide rates have **not** increased since August
   9 (the day after the fire) through the end of
   October 2023.\*
- DOH's review of all reported deaths on Maui shows that suicide and other possible related deaths (such as deaths due to substance use) are consistent with previous years' experience. However, the risk persists and DOH will continue to provide support and monitor.

\*DOH staff reviewed emergency medical services and provisional Electronic Death Records System data and concluded that incidents of self-harm documented in those sources were consistent with previous years for Maui Island.
