Pursuant to Section 3.44.015 H. of the Maui County Code, this letter shall serve as notice that the County of Maui has accepted the dedication of a Waterline Easement by the Department of Water Supply – Engineering Division. The parcel is identified by the subject Tax Map Key Number.

EASEMENT W-1 AFFECTING LOT F

All of that certain parcel of land, being an easement for waterline purposes over, under and across Lot F of the Valley Isle Produce Subdivision No. 3, being also a portion of Grant 3343 to Claus Spreckels situated at Kahului, Wailuku, Island and County of Maui, State of Hawaii

Beginning at a point at the southwesterly corner of this easement, on the easterly side of Hobron Avenue, the coordinates of said point of beginning referred to Government Survey Triangulation Station "LUKE" being 5,183.04 feet North and 11,558.94 feet East and running by azimuths measured clockwise from True South:

1.	163°	05'	15.21 feet	along the easterly side of Hobron Avenue to a point;
2.	262°	42'	606.72 feet	over and across Lot F of the Valley Isle Produce Subdivision No. 3 to a point;
3.	172°	42'	39.25 feet	over and across same to a point;
4.	262°	42'	15.00 feet	along the remainder of Grant 3343 to Claus Spreckels (being along T.M.K: (2) 3-7-011:013) to a point;
5.	352°	42'	54.25 feet	over and across Lot F of the Valley Isle Produce Subdivision No. 3 to a point;
6.	82°	42'	619.18 feet	over and across same to the point of beginning and containing an Area of 9,896 Square Feet.


