

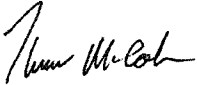

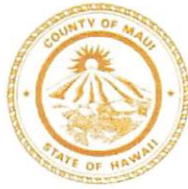

**SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2024 BUDGET
(APPENDIX B, DEPARTMENT OF WATER SUPPLY)**

On behalf of the Department of Water Supply, I am transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI, APPENDIX B, DEPARTMENT OF WATER SUPPLY."

The purpose of the proposed bill is to amend the Fiscal Year 2024 Budget, Appendix B, Revenues – Fees, Rates, Assessments and Taxes, Department of Water Supply, Water Fund, to 1) add two new categories "Emergency Water Charge" and "Temporary Irrigation Charge" prior to Fire Water Service Rates; 2) to add "In accordance with Section 14.04.040, Subsection (M), Maui County Code, the Director has discretion to waive any of the costs associated with water service installation for properties in which infrastructure was destroyed or otherwise rendered non-operational due to disaster or emergency and resulting

in a proclamation of a state of emergency” to Installation Charges; and 3) add “In accordance with Section 14.07.080, Subsection (F), Maui County Code, the Director has discretion to waive the water development fee for properties in which a water meter was destroyed or otherwise rendered non-operational due to disaster or emergency and resulting in a proclamation of a state of emergency” to Water System Development Fees.

These amendments are intended to help customers that have been impacted by a disaster or emergency by offering reduced water rates and by allowing the Director to waive the water system development fee and application charges where an existing water meter has been destroyed or otherwise rendered non-operational due to an emergency or disaster.

A BILL FOR AN ORDINANCE AMENDING
THE FISCAL YEAR 2024 BUDGET FOR THE COUNTY OF MAUI,
APPENDIX B, DEPARTMENT OF WATER SUPPLY

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. Ordinance No. 5528, Bill No. 22, CD1, FD2 (2023), as amended, "Fiscal Year 2024 Budget", Appendix B, Revenues – Fees, Rates, Assessments and Taxes, Department of Water Supply, Water Fund, is amended to add two new categories "Emergency Water Charge" and "Temporary Irrigation Charge" prior to Fire Water Service Rates, to read as follows:

SECTION 2. Fiscal Year 2024 Budget, Appendix B, Revenues – Fees, Rates, Assessments and Taxes, Department of Water Supply, Water Fund, Installation Charges, is amended to add "In accordance with Section 14.04.040, Subsection (M), Maui County Code, the Director has discretion to waive any of the costs associated with water service installation for properties in which infrastructure was destroyed or otherwise rendered non-operational due to disaster or emergency and resulting in a proclamation of a state of emergency", to read as follows:

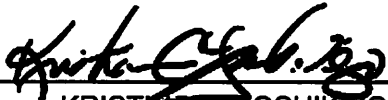
In accordance with Section 14.07.080, Subsection (F), Maui County Code, the Director has discretion to waive the water development fee for properties in which a water meter was destroyed or otherwise rendered non-operational due to disaster or emergency and resulting in a proclamation of a state of emergency.

Water system development fee rates as of April 1993 will apply to requests of applicants on the priority list for upcountry, pursuant to Section 14.13.090, MCC, as of October 31, 2001 up to a maximum of three lots."
