WHEREAS, there is an existing vacancy on the Salary Commission that expires on March 31, 2022; and

WHEREAS, pursuant to Section 13-2(17), Revised Charter of the County of Maui (1983), as amended ("Charter"), the Mayor's thirty-day period to nominate an individual to fill that vacancy expired on February 13, 2019; and

WHEREAS, the Council is currently within its sixty-day period, which will expire on April 14, 2019, to nominate and approve the appointment of an individual to fill that vacancy; and

WHEREAS, Dawnalyn Fujiwara has indicated a desire to be appointed to the Salary Commission and has submitted a completed application form with the information required by Section 2.41.020, Maui County Code; now, therefore,
