- CHAIR U'U-HODGINS: ... (gavel)... That's really loud. Good morning...good afternoon. Will the Government Relations, Ethics, and Transparency Committee meeting of February 27th, 2024, please come to order. It is 1:44 p.m. I'm your Chair Nohelani U'u-Hodgins. Members, in accordance with the Sunshine Law, please identify by name who, if anyone, is in the room, vehicle, or workspace with you today. Minors do not need to be identified. Let's begin with Committee Vice-Chair Tamara Paltin. Good afternoon.
- VICE-CHAIR PALTIN: Good afternoon and aloha 'auinalā. Streaming live and direct from *(audio interference)*.

CHAIR U'U-HODGINS: Okay. Thank you. Councilmember Tom Cook, good afternoon.

COUNCILMEMBER COOK: Good afternoon, Chair.

CHAIR U'U-HODGINS: Councilmember Gabe Johnson, good afternoon.

COUNCILMEMBER JOHNSON: Good afternoon, Chair. There is no testifiers at the Lāna'i District Office. I'm here and ready to work. Mahalo.

CHAIR U'U-HODGINS: Thank you. Councilmember Tasha Kama, good afternoon.

COUNCILMEMBER KAMA: Good afternoon, Chair.

CHAIR U'U-HODGINS: Council Chair Alice Lee is excused for now. Councilmember Keani Rawlins-Fernandez, good afternoon. Oh, she's stuck. Kasie, she's stuck. We'll get back to her in a bit. Councilmember Shane Sinenci, good afternoon.

COUNCILMEMBER RAWLINS-FERNANDEZ: I'm back. I'm back.

CHAIR U'U-HODGINS: Okay. Oh, wait. Okay, there you are.

COUNCILMEMBER RAWLINS-FERNANDEZ: Sorry. I'm sorry, I got frozen.

CHAIR U'U-HODGINS: No, you're good.

COUNCILMEMBER RAWLINS-FERNANDEZ: I'm good now?

CHAIR U'U-HODGINS: Yes.

Moloka'i Nui A Hina. I'm at the Moloka'i District Office. Alone on my side of the office. And we currently have no testifiers here.

CHAIR U'U-HODGINS: Okay. Thank you. (audio interference)

COUNCILMEMBER SINENCI: (audio interference)

- COUNCILMEMBER SUGIMURA: Thank you very much, and I hope Rosco joins us again. Thanks.
- CHAIR U'U-HODGINS: Yeah, he's sweet. From Corporation Counsel we have Victoria Takayesu, Corporation Counsel; Kristin Tarnstrom, Deputy Corporation Counsel; and John Gores, Deputy Corporation Counsel. From our Committee Staff we have today Pauline Martins, Senior Committee Secretary; Kasie Apo Takayama, Senior Legislative Analyst; Clarissa MacDonald, Legislative Analyst; Richard E. Mitchell, Legislative Attorney; Jean Pokipala, Council Services Assistant Clerk; and Jennifer Yamashita, the Committee Secretary. Please see the last page of the agenda for information on meeting connectivity. I'm going to go into the testifier language now. So, testifiers wanting to provide testimony should sign up at the beginning, join the online meeting via Teams link, or call into the phone number noted on today's agenda. Written testimony is encouraged and can be submitted via the eComment link at mauicounty.us/agendas as well. Under the Sunshine Law, the Chair will receive oral testimony for agenda items at the beginning of the meeting and as well as the item is called up. For individuals wishing to testify via Teams, please raise your hand by clicking on the raise your hand button. For those calling in, please follow the prompts via the phone. Staff will add names to the testifier list in the order the testifier sign up or raise their hands. For those on Teams, Staff will lower your hand once your name is added. Staff will then call the name you're logged in under or the last four digits of your phone number when it is your turn to testify. At that time Staff will also enable your microphone and video. If you wish to testify anonymously, please notify Staff. Otherwise, please state your name for the record at the beginning of your testimony. Oral testimony is limited to three minutes per item. If you are still testifying beyond that time, I will kindly ask you to please complete your testimony. We will do our best to take up each person in an orderly fashion, and we will now call on testifiers wishing to testify at the beginning of the meeting. Staff, can we please call our first testifier?
- MS. MACDONALD: Yes, Chair. The first individual signed up to testify is Christopher Fishkin, to be followed by Sam Small. *(Audio interference)* is unmuted on our end.

- CHAIR U'U-HODGINS: Mr. Fishkin. Why don't we go to our next testifier. We can call him when we're done.
- MS. MACDONALD: Yes, Chair. The next testifier is Sam Small.
- CHAIR U'U-HODGINS: Okay. Mr. Small. Is he unmuted on our end? If you could unmute on your end, you can begin your three minutes of testimony.
- MS. MACDONALD: Yes, Chair. He's unmuted on our end.
- CHAIR U'U-HODGINS: Do we have anybody else signed up?
- MS. MACDONALD: Just those two, Chair.
- CHAIR U'U-HODGINS: Okay. Well, why don't we --
- MR. SMALL: Wait a minute.
- CHAIR U'U-HODGINS: Oh.
- MR. SMALL: Hang on.
- CHAIR U'U-HODGINS: Okay, we can hear you.
- MR. FISHKIN: Hello. Hello.
- MR. SMALL: Hi, we were previous...neither of us were previously unmuted until just now.
- CHAIR U'U-HODGINS: Okay. Well, if Mr. Fishkin is on, he can testify, since his name was signed up first, and then Mr. Small, you can follow.

- MR. SMALL: Sounds good to me.
- MR. FISHKIN: Okay, can you hear me?
- CHAIR U'U-HODGINS: We can.
- MR. FISHKIN: Can you see me?

- CHAIR U'U-HODGINS: I'm not too sure.
- MR. FISHKIN: I mean I'm...I mean I can see all of you.
- CHAIR U'U-HODGINS: Yeah, your name is just in a bubble. But we can hear you.
- VICE-CHAIR PALTIN: You have a screen...do you have like something over your camera, so that it's blocking --
- MR. FISHKIN: No, nothing. Nothing over the camera. It went on at the beginning.
- CHAIR U'U-HODGINS: Mr. Small's camera is blocked. Mr. Fishkin's camera we can't see. But you're welcome to continue to testify.
- MR. FISHKIN: Okay, well I'll just...I'll continue to testify. You don't need to see my good looking face. Okay. I'm going to be testifying on all three resolutions. Briefly on two and mostly on 24-13, the reso. Good afternoon, Councilmembers. I'm Christopher Fishkin of Maui Public Advocacy. I was a paralegal for one of Mr. Salem's attorneys in the subject matter case before you requesting additional funding for special counsel. Being that it's lent, it must be penance for you having to listen to me, so I will try to be helpful. As many of you are aware, I conducted an investigation pertaining to violations of the Administration's procurement of special counsel KSG in this case. I also requested access to government records from Corp. Counsel, who handled the procurement for the Finance Director. They denied me access to what I requested, that is the billing invoices of special counsel to date and the names of the selection committee members, which are Corp. Counsel attorneys responsible for qualifying KSG attorneys to be special counsel. Upon Corp. Counsel's denial, I contacted the OIP, which determined that Corp. Counsel's response to me was "indeed incomplete," quote and quote, "defective". The OIP letter to Corp. Counsel informing them about that, as well as my official letter to Scott Toriso *[sic]* of...the Chief Procurement Officer now for the Administration are in my written testimony. Two important things to note. First, one of the attorneys who is a partner at KSG, Craig Shikuma, was not one of the attorneys who was in the procurement letter requesting to be qualified for procurement. And this attorney has been actively representing the County as special counsel, and quite poorly I might add. KSG attorney Max Ching also in a recent filing was not validly procured as special counsel either. So, they were not lawfully procured to represent the County as of about a week ago when I received that qualification letter from Corp. Counsel. Moreover these attorneys have misrepresented the claims in this case to the court, which is exposing the County to additional liability. Second, you are deciding upon authorizing new funding for a reso

brought to you by Corp. Counsel on special counsel's behalf. They only made that resolution after I called out special counsel for clearly exceeding the previous funding authorization as their work product has been far in excess of that amount. So, where are the invoices between then and this additional funding request for all the previous work done? Has some other funding source like a Corp. Counsel slush fund paid any of these invoices? In violation of your funding authorization, because essentially special counsel is trying to cover their okole and other administrative directors in this case. Your special counsel wrote in a letter to Mr. Salem, which I've included in testimony, that it would be unlawful for them to settle on these claims by enforcing County laws, rules, or ordinances as part of a settlement. Did you actually approve that? I doubt it. Because that has to be approved by the client, which is both you and the Administration. Of course, you didn't see that letter, which is also a violation of the Hawai'i Rules of Professional Conduct, which should result in disciplinary action against Mr. Shikuma. This is the tip of an iceberg, and they are the captain of your County Titanic. You have more problems coming down the line with this case than you can shake a stick at. . . . (timer sounds). . . Councilmembers, included in my written testimony is a summary --

- MS. MACDONALD: This is timer for the first item.
- MR. FISHKIN: -- of Mr. Salem's case. Excuse me. Can I just finish this last sentence that I was reading, please?
- CHAIR U'U-HODGINS: Yep, you can. And then you got to move on to the next.
- MR. FISHKIN: Councilmembers, included in my written testimony is a summary of Mr. Salem's case so you can better understand why the Administration has been concealing records for decades pertaining to how the deferral agreements and the SMA permits work together to defraud the County. In this case Mr. Salem was just caught in the middle of that and has been trying to undue the harm to him and the County ever since. Thank you. Do I get to be asked any questions on that or do I go through all the others first?
- CHAIR U'U-HODGINS: You can go to the others, and then at the end of your testimony, we can ask you questions.
- MR. FISHKIN: Okay, thank you.
- CHAIR U'U-HODGINS: You're welcome.
- MR. FISHKIN: So, thank you. So, the...as far as the resolution authorizing the McCorriston firm to represent the County, I just want to say that they are a very good firm, and I think they'll do very well. They're actually witnesses, ironically,

to Christopher Salem's case. They wrote a letter to the County some time back confirming his claims to be noted. Secondly, the other resolution which revolves around Ron Ogomori. I just want to mention that he was the attorney that represented the Sand Hills development when Pat Wong had this Council buy it back from them when there was an affordable housing development proposal on the table. I have requested for decades forensic...a forensic review of Ron Ogomori and Pat Wong because Pat Wong never gave his...the former Corp. Counsel never gave his tax records to this Council, and so I personally believe that there was a private deal there that never got investigated. So, I'm just putting all this stuff on the table for whatever it's worth. And I am done. Thank you. If you have any questions, I am absolutely available to answer them.

- CHAIR U'U-HODGINS: Okay. Thank you. Members, do we have any questions? Member Johnson, go ahead.
- COUNCILMEMBER JOHNSON: Thank you, Mr. Fishkin. I just want to clarify, what letter were you talking about? Do you know the date that letter was sent?
- MR. FISHKIN: Oh, it is...yes, I do. But it's...hold on. I can tell you right now. The letter that I was just referring to in testimony you mean?

COUNCILMEMBER JOHNSON: Yes.

- MR. FISHKIN: Yes. That...the letter was dated October 13th, 2023.
- COUNCILMEMBER JOHNSON: Thank you for clarifying that up. Thank you, Chair. No further questions.
- CHAIR U'U-HODGINS: Thank you, Member Johnson.
- MR. FISHKIN: No further questions for me about any of this investigation I've done freely at my own expense. Okay. Thank you very much, Councilmembers. Have a nice day.
- CHAIR U'U-HODGINS: You too. Mr. Small, your three minutes can begin.
- MR. SMALL: Yeah, well it's going to be more because all three of your resos. So, we'll start --
- CHAIR U'U-HODGINS: Sounds good.
- MR. SMALL: Thank you. We'll start with Chris Salem's case and KSG directly. You know, I usually start saying that it's a pleasure to participate in the democratic process, but it's getting a little dicey. We're losing our ground here in our

democracy, even this chat...this new format that I have to use. Bluejeans worked It actually had a side chat that I was able to communicate with great. Councilmembers privately that proved very valuable, and that's been removed here, and I think that's at the public's disadvantage. All right. So, getting on to Chris Salem, I'm sorry. Does something about this case feel off to you, Corporation Counsel's vigorous defending of themselves? Has Corporation Counsel ever been recused? Have the court forced Corporation Counsel to not represent the County? It happened this time, because Corporation Counsel is itself the source of the problem. Corporation Counsel wrote and hid from everyone thousands of deferral agreements that allowed developers to skip out for paying their capital improvement contributions to County projects for over 40 years. A program got killed because Chris Salem blew the whistle on it. Why is Corp. Counsel committing decades of obstruction regarding the deferral agreements? Because those deferral agreements also contain and hide fraud by department directors in SMA and subdivision permits, and every citizen has standing on SMA and subdivision permit fraud. So, this issue is not just about Chris Salem; this issue is about all Maui citizens, and it's not going to go away. If you think the fraud that allowed developers to avoid infrastructure improvement like firebreaks and waterlines for fire hydrants, if avoiding that infrastructure...building that infrastructure, if you think that that was not a contributing factor to the devastation in Lahaina, there are no kind words to describe you. And that is going to be dredged up by the lawyers who are suing everybody in sight over the fire. The County's negligence in...in...in supervising these directors and Corporation Counsel is going to get you in trouble. And you have the responsibility because the Council has the authority and the obligation to perform investigations into past behaviors by the departments. You can't tell them what to do, but analyzing their past behavior is part of your job. We've got to --

- MS. MACDONALD: This is the timer for the first item.
- MR. SMALL: Great. We'll move over into...into the fire or whatever you want to call it. We...we finally educated the Council. Maybe David Raatz will tell you all about the phone call that we all had with Mike Molina to explain to the Councilmember that the County has...the Council has the authority to investigate any department actions, and you have to do that with the fire. You have to do that with all the contributing factors, and that includes the deferral agreements. The Coun...Corporation Counsel penetrated the independence of the County auditor. They got the auditor to shut down his audit of the deferral agreements. That is not legitimate. That is a public issue, and the County will be held accountable for it. We're not going away. KSG here, Mr. Fishkin just detailed you, you know, how the procurement of KSG in this case is completely fraud...in the Salem case is completely fraudulent. That will come back to bite this Council today because you're accepting lies from Corporation Counsel. I...I

was in court last week where KSG attorney lied directly to Judge Cahill saying that Chris Salem's emails and work product were destroyed, that the hard drives were wiped clean when his employment was terminated. That does not happen. No one in the department would ever consider that that being appropriate procedure. Chris Salem, you know, is there...was there working for the County documenting these many issues of fraud and corruption from within the department, because I helped convince Mike Victorino that that would be a good thing. He was going to be the man who fixed all of this crap, and obviously Corp. Counsel got the better of him and shut him down. But we're not going away. So, KSG is going to ask you for \$75,000 today; that is way under what they've already spent. Are they going to bill you retroactively for the work that they've already done? It's probably over half a million dollars by now. I've been tracking --

- CHAIR U'U-HODGINS: Mr. Small, if you could stick to the agenda item as posted, because your three minutes for the other one has expired. So, if you would like to move on and stay on task, that would be appreciated. Thank you.
- MR. SMALL: Thank you very much for your indulgence. These issues are conflated, and it's difficult to just stay on one of them. That's why this is such an important issue. It's not necessarily about Chris Salem. It's about the issues that he blew the whistle on. And we, as citizens, have a right to pursue this, and you're being asked to destroy that right in court. So, please consider that --
- MS. MACDONALD: Timer for the second item.
- MR. SMALL: -- and thank you very much for your time.
- CHAIR U'U-HODGINS: You're welcome. You still have time for the last item if you said you were going to, but if not...if you're done, we can ask the Members if they have any questions for your...regarding your testimony. Okay, Members do you have any questions for Mr. Small? Seeing none. Thank you very much for your testimony.

MR. SMALL: We'll be back.

CHAIR U'U-HODGINS: Sounds good. Staff, do we have any more testifiers waiting?

- MS. MACDONALD: Chair, we have one other individual, Jasee Kanawai.
- MR. LAW: Aloha awakea, Chair U'u-Hodgins, and Councilmembers, and distinguished guests of the Chambers. I'm glad you're my friend, Madam Chair, because if I ever have to sue the County for my violation of freedom of speech, then I would know you'll be impartial and give me a fair hearing.

- CHAIR U'U-HODGINS: We have before us Resolution 24-13, entitled "AUTHORIZING ADDITIONAL COMPENSATION RELATED TO THE EMPLOYMENT OF SPECIAL COUNSEL KOBAYASHI SUGITA & GODA, LLP, IN CHRISTOPHER SALEM V. COUNTY OF MAUI, ET AL., CIVIL NO. 2CCV-21-0000048." Resolution 24-13's purpose is to authorize additional compensation in the amount of \$75,000 to Kobayashi Sugita and Goda, LLP, as special counsel to represent the County of Maui, Richard T. Bissen, Jr., in his official capacity and Kathleen Aoki in her official capacity in the case noted in the title of the resolution. At this time, I'm going to request opening comments from Deputy Corporation Counsel Gores. Mr. Gores.
- MR. GORES: Yes, we're here today to request additional funding as stated in the resolution. Any questions, I'd be happy to answer them in executive session.

- CHAIR U'U-HODGINS: Okay. So moved. Thank you. Okay, let me find my notes. Give me a second. Okay. Members, we will now entertain a motion, which we did, to move into executive session in accordance with Section 92-5(a)(4), Hawaii Revised Statutes, to consult with legal counsel on questions and issues pertaining to the powers, duties, privileges, immunities --

CHAIR U'U-HODGINS: Can we please mute them? And liabilities of the County, the Council, and the Committee; and Section 92-5(a)(8), Hawaii Revised Statutes, to deliberate or make a decision upon the matter that requires the consideration of information that can be kept confidential pursuant to the State or Federal law, or a court order.

COUNCILMEMBER SUGIMURA: So, moved.

- COUNCILMEMBER KAMA: Second.
- CHAIR U'U-HODGINS: And we have a motion made by Councilmember Sugimura, and a seconded by Councilmember Kama to move into executive session for this item, GREAT-11(38). Is there any further discussion? Member Johnson, go ahead.
- COUNCILMEMBER JOHNSON: Chair, real quick. I know we can ask certain things in executive session that we can't ask out here, so I wanted to kind of ask, can we get a breakdown of the case, but we want to go right into executive session, or I may have to come back out here and ask that?
- CHAIR U'U-HODGINS: Sure. Well, a couple of things, this isn't the first time we've had this case in our committee, so you should be relatively familiar about the basics.

If he would like to provide us a brief overview before we go into executive session...is that what you want Member Johnson? We can do that.

COUNCILMEMBER JOHNSON: Okay.

- CHAIR U'U-HODGINS: Sure. If you can provide us any information in open session, I'd appreciate that, Mr. Gores.
- MR. GORES: Sure. This matter has been litigated for quite some time by Mr. Salem against the County. And there has been extensive motion practice. There was a settlement conference that failed. And the matter for trial has been continued, and I don't recall the date at which the new trial date is set. I don't think it has been, at least the last I had heard. But that will be coming up, and I anticipate based on the history there will likely be additional motion practice.
- COUNCILMEMBER JOHNSON: Thank you. I just wanted to inform the public of where we were at and at this point in time. So, thank you, Chair.
- CHAIR U'U-HODGINS: Thank you. Okay. Well, I appreciate that discussion. Do we need any further discussion before we vote? You good? Okay. Member Paltin.

VICE-CHAIR PALTIN: Sorry.

CHAIR U'U-HODGINS: We have before us Resolution 24-16 entitled, "AUTHORIZING ADDITIONAL COMPENSATION RELATED TO THE EMPLOYMENT OF SPECIAL COUNSEL MCCORRISTON MILLER MUKAI MACKINNON, LLP IN LITIGATION

MATTERS ARISING FROM THE AUGUST 2023 WILDFIRES ON THE ISLAND OF MAUI," and Resolution 24-17, entitled "AUTHORIZING ADDITIONAL COMPENSATION RELATED TO THE EMPLOYMENT OF SPECIAL COUNSEL MEYERS NAVE IN LITIGATION ARISING FROM THE AUGUST 2023 WILDFIRES ON THE ISLAND OF MAUI." Resolution 24-16 and Resolution 24-17's purpose are to authorize additional compensation in the amount of \$250,000 to McCorriston Miller Mukai and MacKinnon, LLP, and \$250,000 to Meyers Nave, as special counsels to represent the County of Maui in current and anticipated litigation matters related to the August 2023 wildfires on the Island of Maui. At this time, I'm going to request open...opening comments from Corporation Counsel.

MS. TAKAYESU: Good afternoon, everyone and thank you. We are here to request additional compensation for the two firms that we have retained to assist us in defending the litigation involving the wildfires. To just give you a snapshot of where we are right now, we have approximately 83 cases that have been filed against the County. We're representing approximately 363 plaintiffs and entities. That is what it is at current, but new cases are being filed every day. At present, we are also divided jurisdictionally between our Federal courts and our State court, which means that that divides our ability, of course, to litigate. I think you'll find that the firms that we have retained who are present on this call, Mr. Jordan Inafuku from McCorriston, Ms. Deborah Fox from Meyers Nave, are also available to discuss these cases with you and why they feel that additional compensation is required. We have at this time exceeded or are about to exceed the invoices that we are being billed for, so we're here to request Council's approval of additional compensation. Thank you.

CHAIR U'U-HODGINS: Okay. Staff, is there anyone wishing to testify on this item?

- MS. MACDONALD: Yes, Chair. The first and only individual signed up to testify is Christopher Salem.
- CHAIR U'U-HODGINS: Is Mr. Salem unmuted on our end?
- MS. MACDONALD: Yes, Chair. He's unmuted on our end. Christopher, if you want to unmute yourself, there's the camera and mic icon in the top right corner. If there's a line through it, it means you're muted.
- MR. SALEM: There we go. How about now?
- CHAIR U'U-HODGINS: We can hear you now. Yep, you're good.

... BEGIN PUBLIC TESTIMONY ON GREAT-11(31)...

Okay, thank you. Thank you, Council Chair. MR. SALEM: Thank you, Councilmembers. I wasn't prepared to testify today, but there is...you know, the nexus between these three matters I think I'll warrant a little bit of further insight and dialogue. In regards to the McCorriston firm, I would support a hundred percent whatever is necessary to defend the County of Maui. As mentioned earlier, McCorriston firm represented my housing group, Anuenue Housing Group, which is the entity that's...we are the ones who resolved the Palama Drive litigation. That was not resolved by Corporation Counsel. It was a wonderful gentleman on the nationwide affordable housing who I grew up with in San Clemente, who spent a year and a half with Randy Schmidt from McCorriston and Ron Okomori. There's a nexus to the next item. And that complexed litigation was settled by us. Unfortunately, which is a parallel here---and I need to mention that I was trying to testify earlier on the other item and I don't know why in this new system it wouldn't let me in, so I feel a little bit of prejudice of not being able to testify prior to the executive session. That was not fair, but...and I would like the opportunity to do so before this meeting is over with. So, I support the McCorriston firm. I can tell you what they did for Palama Drive in that situation for the Cabebes, et cetera, and also a very, very troubling situation at the end with Adrian Owen, who actually died of cancer fighting that battle and as that land still sits there. We had an amazing affordable...hundred percent affordable housing project all ready to go. My background, many Members may not know me, but I built over 450 residential units in my career, and I was fully prepared, and we were as an affordable housing company, to show this County how it's done nationwide to actually build out that development. Unfortunately, that settlement agreement, which I think is the nexus to today, was withheld from the Maui County Council. Mayor Victorino has affirmed that. Instead, the developer was paid upwards to \$13 million. They originally wanted \$22 million. Through my expertise, we negotiated that down by proving that they actually...the civil engineer Unemori--the same name comes up--intentionally violated the grading ordinances which allowed that project to get approved. So, I feel it's important just for a little bit of credibility in all of this, because I don't understand--and I'll speak to the next item when it's appropriate. I don't understand why you people are doing this to my family. What have I done wrong, except for to uphold your laws? Why are you allowing...it was nine hours of depositions and getting drilled by KSG about trying to paint me as some villain on the ninth floor. When I spent hours and hours on COVID and in the Olowalu fires helping our community. I live in West Maui. It's horrific what my children and their friends' families are dealing with. I'm going to come back, and I want to be able to speak to my item, but I don't know why you're doing this to my family. You have driven us to poverty. All I've done is bring you recovery, and I can't deal with it anymore. I lay in bed and I look at these rafters up there and I just literally...all I visualize is a rope and ending this life. If I didn't have two children, I would end this life. You have destroyed my life by not standing next

to me. Thank you. I'll speak to the next item when it's time. You have destroyed my family.

- CHAIR U'U-HODGINS: Thank you, Mr. Salem. Members, do we have any questions for Mr. Salem before we take our next testifier? Seeing none. Thank you. Staff, next testifier, please.
- MS. MACDONALD: There's currently no one else who is signed up to testify. If somebody would like to testify in the Chamber, please let Staff know.

CHAIR U'U-HODGINS: Sorry.

MS. MACDONALD: Oh, I see an individual coming to the podium now.

- CHAIR U'U-HODGINS: Thank you. And as a reminder, written testimony will continue to be accepted. Members, we will now move on to a three-minute questioning period with a one-minute follow-up round for the things we can discuss in open session. So, if anybody has questions before we move on. Oh my gosh, does anybody have questions? Are we sure? Okay. Oh, Member Paltin. Go ahead, Member Paltin.
- VICE-CHAIR PALTIN: Thank you, Chair. I would like to know what we can know in open session if there is anything we can know?

CHAIR U'U-HODGINS: Me too.

- MS. TAKAYESU: Sure. Well, as discussed, we are looking at over 80 individual lawsuits. Again, representing a multitude of plaintiffs and entities, with more coming every day. Our inhouse department is...has only so much resources to expend on the defense of all of these cases, so it is imperative that we continue to use the law firms that we have retained in order to assist us in getting the best possible defenses for the County. If there's a specific question, I can answer it, but because this does, you know, involve litigation and our special counsel, I think I'd prefer to answer any other questions in executive session if they are more detailed.
- VICE-CHAIR PALTIN: I just have a follow up. So, it's about...we're about maybe seven...six, seven months out from the fire itself and maybe six...five, six months since we retained special counsel. This tranche that is being asked for, it's not supposed to see us through to the end of things. It's just to tie us over until like another five months pass or so?
- MS. TAKAYESU: They're...well, we have some issues I think we could discuss more indepth in executive session, but I would...I would project that at the end, their bill will...this...this money that we're requesting today will not carry us all the way through to the end of litigation.

VICE-CHAIR PALTIN: Okay, thank you.

CHAIR U'U-HODGINS: Okay. Members. Member Sinenci.

- COUNCILMEMBER SINENCI: Thank you, Chair. I was just curious, these funds do not come out of like the settlement fund? It's from another?
- MS. TAKAYESU: These funds are coming out of our own general fund. They are selfinsured retention. This is what's...we're paying out until we reach the limit where insurance...we can tender it to our insurance carrier.
- COUNCILMEMBER SINENCI: Okay. Thank you. Thank you, Chair.
- CHAIR U'U-HODGINS: Of course. Members, any other questions before we move into executive session? No. Okay. - CHAIR U'U-HODGINS: Thank you. Motion made by Member Sugimura, second by Member Kama. One second, as we confirm some things. Give us a minute, Members. Okay. Members, one second. Remi is going to have to provide us some legal advice in the moment, so Remi.
- MR. MITCHELL: Thank you, Chair. I believe Member Paltin has someone else in her car. Is that correct, Member Paltin?
- CHAIR U'U-HODGINS: Yes.
- VICE-CHAIR PALTIN: That's correct, but I'm passing Kā'anapali Parkway right now, and when we get to Lahaina Civic, I can lock myself alone in the car, and I can have them do my other work that I'm supposed to take care of.
- MR. MITCHELL: Member Paltin, how far away are you from the Civic Center?
- VICE-CHAIR PALTIN: I would guestimate five to ten minutes, but there is quite a bit of traffic. I don't know if you guys are aware, but there's only one way in and one way out of West Maui. And so the eight o'clock and four o'clock hours are the worst times to be traveling. There is no rapid transportation from Central to West Maui, as was alluded to earlier. So, I'd say ten minutes. Maybe less.

- MR. MITCHELL: Thank you, Member Paltin. I think what we would like to do is proceed with the vote for executive session without you voting if that's okay, because you would count towards the vote, but there's no ability to bring you into the meeting timely since it's going to take you maybe ten minutes to get to where you are, so we might need to have you excluded from executive session.

CHAIR U'U-HODGINS: Thank you. Thank you, Members. This item will move on to full Council for its consideration. Now moving on.

GREAT-11(37)LITIGATION MATTERS (RESOLUTION 23-248, RELATING TO
SPECIAL COUNSEL AUTHORIZATION: RONALD T. OGOMORI TO
REPRESENT HERMAN ANDAYA IN AMIR HOSSEIN SHEIKHAN,
ETC., ET AL., V. HAWAIIAN ELECTRIC INDUSTRIES, ETC., ET
AL., CASE 2CCV-23-0000260)

- CHAIR U'U-HODGINS: We have before us Resolution 23-248, entitled "AUTHORIZING THE EMPLOYMENT OF SPECIAL COUNSEL RONALD T. OGOMORI, ATTORNEY AT LAW, A LAW CORPORATION, TO REPRESENT HERMAN ANDAYA IN AMIR HOSSEIN SHEIKHAN, ETC., ET AL. V. HAWAIIAN ELECTRIC INDUSTRIES, ETC., ET AL., CIVIL NO. 2CCV-23-0000260." Resolution 23...23-284's [*sic*] purpose is to authorize the employment of Ronald T. Ogomori, Attorney at Law, a Law Corporation, as special counsel to represent Herman Andaya in Amir Hossein Sheikhan, etc. et al. v. Hawaiian Electric Industries, etc. et al., Case 2CCV-23-0000260 for a total compensation amount not to exceed \$150,000. At this time, I'm going to please ask for opening comments from Corporation Counsel.
- MS. TAKAYESU: Thank you, Chair. This resolution seeks Council approval to hire special counsel for Herman Andaya, who was named as a defendant in the complaint attached to the resolution. The complaint alleges that Mr. Andaya, as the MEMA administrator, owned a duty to warn the public generally of the pending emergency and breached that duty. All of the facts that are alleged in

that complaint are considerably within the course and scope of his employment. Typically, the County does provide a defense to its employees when they are sued for acts or omissions that are within the course and scope of their duties. So, as this matter is in active litigation, we are going to request executive session to address further issues in this matter. Thank you.

- CHAIR U'U-HODGINS: Thank you. Before we get into discussion, can we please do a last call on testimony for this item GREAT-11(37)?
- MS. MACDONALD: Yes, Chair. The first individual signed up to testify is Christopher Salem, to be followed by Sam Small.
- CHAIR U'U-HODGINS: Okay. Mr. Salem. Is Mr. Salem unmuted on our end, and he just needs to unmute on his?
- MS. MACDONALD: Yes, he is unmuted on our end. He'll just have to unmute the camera and mic button on his end.
- CHAIR U'U-HODGINS: Okay.
- COUNCILMEMBER RAWLINS-FERNANDEZ: Chair, it doesn't look like his mic is enabled. It has the circle with the line through it.
- MS. MACDONALD: Chair, he is unmuted on our end, but I think it's showing because he needs to unmute his mic on his end.

CHAIR U'U-HODGINS: Okay.

- COUNCILMEMBER RAWLINS-FERNANDEZ: No, but it has the circle with the line through it. It doesn't have just a line through the mic. That's what I'm seeing.
- CHAIR U'U-HODGINS: Okay. That's not what they're seeing on their end, so...yeah. There might be an interesting Teams issue. Okay, well --
- COUNCILMEMBER RAWLINS-FERNANDEZ: Okay, now it...there's the line through the mic. Now it should work.
- CHAIR U'U-HODGINS: Okay. Mr. Salem, please unmute yourself. Okay. Well, maybe we can go to Mr. Small and then we can come back to Mr. Salem after Mr. Small. Can we unmute Mr. Small, please? Thank you.

MR. SMALL: I have been activated. Look at that.

CHAIR U'U-HODGINS: Yep.

CHAIR U'U-HODGINS: Yep, we can hear you.

... BEGIN PUBLIC TESTIMONY ON GREAT-11(37)...

- MR. SMALL: Okay. Before we get into this, if I may, I'm trying to understand how...I tried calling in because I...I needed to leave the computer, and I tried to call in using the telephone number that's on the agenda that tells me public testimony can be made by calling in, and I entered the code to get to this meeting, and on the telephone my telephone accessed the meeting. There's no way to raise my hand. So, how can someone call in and testify?
- MS. MACDONALD: Sir you should be able...the telephone should prompt you, and it's star five to be able to raise your hand. Star five.
- MR. SMALL: There was no prompt. There was no prompt. I was prompted to enter the code for the meeting, and then I was told you...you will be let in, and then I was let in, and that was the end of it. No more communication, and it's only a telephone, so there's no way to...there's no way to get anybody's attention. In the online tool, there's a way to raise your hand.
- CHAIR U'U-HODGINS: Mr. Small, if you could please...we hear you. If you could please continue with your testimony, and for future reference, it's star five.
- MR. SMALL: Well, that's not on your agenda. So, if that's a part of your instruction --
- CHAIR U'U-HODGINS: Okay. So, would you like to testify on the item we have on the agenda now, because this is not agendized?
- MR. SMALL: I will, but this meeting is in violation of Sunshine. Is it not?

CHAIR U'U-HODGINS: No. Would you like to please testify?

- MR. SMALL: How is it not? I tried to call in and testify using my phone as per your instructions, and I wasn't able to do it. It says nothing about star five. So, unless--I had to come back to be able to raise this issue with you using the online utility not my phone. My...it is a Sunshine violation. How is it not?
- CHAIR U'U-HODGINS: Okay. Mr. Small, one second. Member Rawlins-Fernandez, did you have a question?

COUNCILMEMBER RAWLINS-FERNANDEZ: Mahalo, Chair. I just wanted to note

Staff's practices. When we do have a phone number, Staff does make the effort to try to ensure that the phone number calling in, if they want to testify, they have that opportunity to testify. I see your number now, but I didn't see a phone number earlier. But I agree with you, Mr. Small, that Teams has been not...nowhere near as user friendly as BlueJeans, and we are trying our best.

- MR. SMALL: Is there any intention to go back to BlueJeans?
- COUNCILMEMBER RAWLINS-FERNANDEZ: BlueJeans is no longer an option.
- CHAIR U'U-HODGINS: BlueJeans no longer exists. Yeah.
- MR. SMALL: Okay. Thank you for the distraction. I don't know what to do about, you know, this is...today, I mean--they do their best, but it's not accomplished. So, that's not my...I'm glad they do their best, and they're failing. So, that needs to be addressed. Simply add it to the agenda, you know, star five. Great. Great information. But the fact remains is it's not there.
- COUNCILMEMBER RAWLINS-FERNANDEZ: We can look to adding that in, Mr. Small.
- MR. SMALL: Okay. Thank you for that.
- COUNCILMEMBER RAWLINS-FERNANDEZ: If you want to provide your testimony.
- CHAIR U'U-HODGINS: Okay. Yeah, Mr. Small, we're going to have to move on. We can have this conversation offline, but if you would like to start your testimony. Go ahead.
- MR. SMALL: Thank you...thank you very much. Look, the...the research that I've done around the law firm and lawyer that is being proposed here is problematic. I would ask you guys to ask for additional disclosures on conflicts of interest, which appears to be based on the procurement of KSG that appears to be problematic. It's something that is not properly pursued. In the KSG situation, you've got attorneys that are representing the County that were never procured. In Ogomori's case, you've got a prior relationship related to Palama Drive, and that's how all these things, you know, are interrelated. Because Christopher Salem was part of an initiative to develop Palama Drive with a 100 percent affordable housing proposal that never got presented to the County Council because of Pat Wong, who was Corporation Counsel at the time. Pat Wong has a...we believe an undisclosed relationship with Ron Ogomori. And Ron Ogomori was representing the developer, Pat Wong was representing the County, and both were involved with the affordable housing proposal that Mr. Salem and his team presented. Pat Wong at the last minute withheld that proposal from the County Council, stating that there were procurement issues over it, that the Council

could not accept the proposal because it didn't ask for a request from proposals for a third-party to purchase the land, and that that was a procurement violation. But all of a sudden today, this Council is entertaining giving those same properties away to an affordable housing initiative with no procurement provided. There's...they're not paying anything for it. So, there's no...why was Chris Salem's proposal illegal? Because there was no proper procurement. How can the County possibly give the same land away now with no procurement? Because what Pat Wong manufactured as an excuse with Ron Ogomori's participation was a fabricated lie. And we believed that Pat Wong's gambling winnings--which this Council had the opportunity to ask for his tax returns, the specifics, and the Council did not do it. You had the opportunity to verify the citizen's suspicions that those gambling winnings over...up to a million dollars were not gambling winnings. They were related to the side deal that was cut between Pat Wong and Ron Ogomori. I have no direct proof, but there's certainly enough to investigate the situation. And Ron Ogomori is a problem --

CHAIR U'U-HODGINS: Okay.

MR. SMALL: -- because of his prior relationship with Pat Wong. So, your disclosure...your lack of disclosure on all of these attorneys is a problem with KSG, it's a problem with Ron Ogomori, and it's a problem with Corporation Counsel, who as Councilmembers --

CHAIR U'U-HODGINS: Okay, Mr. Small if you could wrap up, please.

- MR. SMALL: -- you should not trust. I'm done. Thank you. You should not trust Corporation Counsel, because we will get them to the Supreme Court.
- CHAIR U'U-HODGINS: Thank you, Mr. Small. Okay. Thank you very much. Members, do you have any questions for Mr. Small? No. Seeing none. Thank you, Mr. Small. Staff, can you please call the next testifier?

MR. SMALL: Good luck.

CHAIR U'U-HODGINS: Thank you.

MS. MACDONALD: Yes, Chair. The next testifier is Christopher Salem.

CHAIR U'U-HODGINS: Mr. Salem, if you could please unmute yourself on your end.

MS. MACDONALD: Yes. He's been fully unmuted on our end.

CHAIR U'U-HODGINS: Okay. Mr. Salem.
