Chair and Members:

Your Budget, Finance, and Economic Development Committee, having met on October 22, 2024, makes reference to Bill 140 (2024), entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE 15TH SPACE SURVEILLANCE SQUADRON, AIR FORCE MAUI OPTICAL & SUPERCOMPUTING, AND AIR FORCE RESEARCH LABORATORY FOR FIRE AND EMERGENCY/NON-EMERGENCY SERVICES."

Bill 140's purpose is to authorize the Mayor to enter into an intergovernmental agreement with the 15th Space Surveillance Squadron, Air Force Maui Optical & Supercomputing, and Air Force Research Laboratory to detail the firefighting, emergency and non-emergency services, and hazardous materials incident response provided by the Department of Fire and Public Safety for the protection of specified military facilities on Maui.

Your Committee notes that the list of protected military facilities, include Maui Space Surveillance Complex on the summit of Haleakalā, an experiment site in Kīhei, and a logistics center in Kahului.

A representative from the Department of Fire and Public Safety said while there would be elevation-related challenges at the summit, none would prevent the Department from responding to an emergency.

Your Committee further notes that under Section 2.20.020, Maui County Code, the Mayor must not enter into any intergovernmental

agreement or any amendment that places a financial obligation on the County or any department or agency without Council authorization.

The Department representative confirmed that there would be no funds exchanged with this agreement. Further, the Department would not be held to specific response times or any activities the Department is unable to perform. However, the agreement does allow for the exchange of information so the Department can plan for unique hazards that may be encountered at the facilities.

The Department representative explained that the County entered into a similar agreement with the Air Force, but since the facilities were transferred to the Space Force, a new agreement was necessary.

Your Committee supported amending Bill 140 to ensure consistency with the structure for intergovernmental agreement authorization bills agreed upon with the Department of the Corporation Counsel.

Your Committee voted 8-0 to recommend passage of Bill 140, CD1 (2024), on first reading. Committee Chair Sugimura, Vice-Chair Kama, and members Cook, Johnson, Lee, Paltin, Sinenci, and U'u-Hodgins voted "aye." Committee member Rawlins-Fernandez was excused.

Your Committee is in receipt of Bill 140, CD1 (2024), entitled "A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE 15^{TH} SPACE SURVEILLANCE SOUADRON, AIR FORCE MAUI OPTICAL SUPERCOMPUTING, AND AIR FORCE RESEARCH LABORATORY FOR FIREFIGHTING, EMERGENCY AND NON-EMERGENCY SERVICES, AND HAZARDOUS MATERIALS INCIDENT RESPONSE," approved as to form and legality by the Department of the Corporation Counsel, incorporating your Committee's recommended revisions and nonsubstantive revisions.

A BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT WITH THE 15TH SPACE SURVEILLANCE SQUADRON, AIR FORCE MAUI OPTICAL & SUPERCOMPUTING, AND AIR FORCE RESEARCH LABORATORY FOR FIREFIGHTING, EMERGENCY AND NON-EMERGENCY SERVICES, AND HAZARDOUS MATERIALS INCIDENT RESPONSE

BE IT ORDAINED BY THE PEOPLE OF THE COUNTY OF MAUI:

SECTION 1. The County of Maui and the 15th Space Surveillance Squadron, Air Force Maui Optical & Supercomputing, and Air Force Research Laboratory seek to enter into an agreement for firefighting, emergency and non-emergency services, and hazardous materials incident response, as described in the Memorandum of Agreement attached as Exhibit "1."

Section 2.20.020, Maui County Code, provides, "Unless authorized by ordinance, the mayor shall not enter into any intergovernmental agreement or any amendment thereto which places a financial obligation upon the county or any department or agency thereof."

SECTION 2. Under Section 2.20.020, Maui County Code, the Council authorizes the Mayor or the Mayor's authorized representative to execute the Memorandum of Agreement and any amendments consistent with the purpose and scope of the Memorandum of Agreement that do not increase the County's financial obligation or the agreement's duration.

SECTION 3. This Ordinance takes effect on approval.

MEMORANDUM OF AGREEMENT BETWEEN **COUNTY OF MAUI, HAWAII** DEPARTMENT OF FIRE & PUBLIC SAFETY, MAUI COUNTY (CMDFPS) AND

15TH SPACE SURVEILLANCE SQUADRON (15 SPSS) AIR FORCE MAUI OPTICAL & SUPERCOMPUTING (AMOS)

AIR FORCE RESEARCH LABORATORY (AFRL) FOR FIRE AND EMERGENCY/NON-EMERGENCY SERVICES AGREEMENT NUMBER: FB2500-230009-0200

This is a Memorandum of Agreement (MOA) between the Maui County Department of Fire and Public Safety and the 15 Space Surveillance Squadron (SPSS). When referred to collectively, Maui County Department of Fire and Public Safety and the 15 SPSS are referred to as the "Parties".

- 1. BACKGROUND: In an effort to enhance space support to the warfighter, the Air Force Research Lab Detachment 15 has been inactivated and transitioned to the Space Force as the 15th Space Surveillance Squadron. This MOA is meant to outline the responsibilities in firefighting, emergency and non-emergency services, and hazardous materials incident response to be held by the County of Maui, Hawaii, Department of Fire & Public Safety (hereinafter to be referred to as the Maui County Fire Department), to be delivered to 15 SPSS, Air Force Maui Optical and Supercomputing Site, Air Force Research Laboratory (AMOS) Maui, Hawaii.
- 2. AUTHORITIES: DoDI 4000.19 Support Agreements, December 16, 2020.
- 3. PURPOSE: This Memorandum of Agreement (MOA) details how the Maui County Department of Fire and Public Safety agrees to offer their services in protection of the following military facilities: Maui Space Surveillance Complex; Remote Maui Experiment Site, 805 East Lipoa Parkway; 15 SPSS HQ, 550 Lipoa Parkway, Kihei, HI 96753; Logistics Center, 360 Ho'ohana Street #B110, Kahului, HI 96732
- 4. UNDERSTANDINGS OF THE PARTIES:
- 4.1. Maui County Department of Fire and Public Safety will:
- 4.1.1. Provide Fire and Emergency Services to military facilities listed in this agreement. When requested, the Maui County Fire Department will respond to facilities primarily occupied by 15 SPSS personnel, to perform fire suppression, emergency medical, and hazardous materials incident response.
- 4.1.2. In the event of a fire, medical, or hazardous materials response request by the 15th SPSS. Maui County Fire Chief will be the Senior Fire Official on scene. If unavailable for response, the SFO will appoint a representative from Maui County Fire to act in his/her stead.

- 4.1.3. Perform facility pre-fire planning and facility/area familiarization.
- 4.1.4. When available, and with prior notification, participate in scheduled 15 SPSS exercises.
- 4.1.5. In the event that simultaneous responses occur to multiple 15 SPSS' Government facilities, provide an emergency vehicle and crew to the following locations in prioritized order:
 - 4.1.5.1 Summit Site:
- 4.1.6.1.a. AEOS, Building 4
- 4.1.6.1.b. MSSS, Building 1
- 4.1.6.1.c. Butler, Building 2
- 4.1.5.2 Sea Level Sites:
 - 4.1.6.2.a. Building 550, Lipoa Pkwy
 - 4.1.6.2.b. Remote Maui Experiment (RME), 805 Lipoa Pkwy
- 4.1.6. All equipment and personnel dispatched to 15 SPSS facilities for purposes of emergency response mitigation and/or training purposes, shall be under the control of the Maui County Department of Fire and Public Safety.
- 4.2. 15th Space Surveillance Squadron will:
- 4.2.1. Provide access for emergency vehicles and personnel from Maui County Department of Fire and Public Safety when responding to an incident at one of the government facilities mentioned in paragraph (3).
- 4.2.2. Supply documentation of inspections, testing, and maintenance of fire suppression/detection systems. Purchase any new or replacement fire extinguishers as required and/or identified by Maui County Department of Fire and Public Safety.
- 4.2.3. Provide Maui County Department of Fire and Public Safety with copies of previous facility pre-fire plans, special hazard information and any other relevant information that would assist Maui County Department of Fire and Public Safety in the performance of their duties while on 15 SPSS property.
- 4.2.4. Provide government specific forms/documents that Maui County Department of Fire and Public Safety may need in order for them to perform their duties on military installations.

5. PERSONNEL: Each party is responsible for all costs of its personnel, including pay and benefits, support, and travel. Each Party is responsible for supervision and management of its personnel. This MOA neither documents nor provides for the exchange of funds or manpower between the Parties, nor does it make any commitment of funds or resources. No provision in this MOA will be interpreted to require obligation or payment of funds.

6. GENERAL PROVISIONS:

- 6.3. FUNDS AND MANPOWER: This MOA neither documents nor provides for the exchange of funds or manpower between the Parties, nor does it make any commitment of funds or resources. No provision in this MOA will be interpreted to require obligation or payment of funds.
- 6.4. MODIFICATION OF AGREEMENT: This MOA may only be modified by the written agreement of the Parties, duly signed by their authorized representatives.
- 6.5. DISPUTES: Any disputes relating to this MOA will, subject to any applicable law, Executive order, directive, or instruction, be resolved by consultation between the Parties or in accordance with DoDI 4000.19.
- 6.6. TERMINATION OF AGREEMENT: This MOA may be terminated by either Party by giving at least 180 days written notice to the other Party. The MOA may also be terminated at any time upon the mutual written consent of the Parties. There is no requirement for reimbursable payment for unavoidable termination.
- 6.7. TRANSFERABILITY: This MOA is not transferable except with the written consent of the Parties.
- 6.8. ENTIRE AGREEMENT: It is expressly understood and agreed that this MOA embodies the entire agreement between the Parties regarding the MOA's subject matter, thereby merging and superseding all prior agreements and representations by the Parties with respect to such subject matter.

- 6.9. EFFECTIVE DATE: This MOA takes effect beginning on the day after the last Party signs.
- 6.10. EXPIRATION DATE: This MOA expires on ten years minus one day after the last Party signs.
- 6.11. CANCELLATION OR MODIFICATION OF PREVIOUS MOA: This is a new MOA.
- 6.12. NO THIRD PARTY BENEFICIARIES: Nothing in this MOA, express or implied, is intended to give to, or will be construed to confer upon, any person or entity not a party any remedy or claim under or by reason of this MOA and this MOA will be for the sole and exclusive benefit of the Parties.
- 6.13. REVIEW OF AGREEMENT: If non-reimbursable, this MOA will be reviewed and validated by both parties no less often than mid-point on or around the anniversary of its effective date in its entirety.
- 7. FINANCIAL DETAILS: This MOA does not provide for reimbursement between the Parties.
