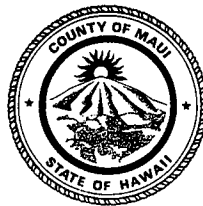

WHEREAS, by correspondence dated October 19, 2018, Mayor Alan M. Arakawa notified the Council that he nominated Justin Bibee to the Commission on Children and Youth for a term expiring March 31, 2021, to fill a vacancy replacing Lucy Feinberg, pursuant to Section 2.39.010, Maui County Code (“MCC”), and Section 13-2, Revised Charter of the County of Maui (1983), as amended, (“Charter”); and


WHEREAS, Section 13-2, Charter, requires the Mayor’s nominee to be approved by the Council; and
