 - b. Alternatively, should the proposed Article 5 be amended to account for these provisions?
- 2. Does the Board of Variances and Appeals' authority under Section 16.18B.109-6 extend to situations that Bill 122 would regulate, such as the design, installation, or inspection of electrical systems

- in factory-built housing or would those fall uniquely under Bill 122's procedures? Please explain.
- 3. If these provisions overlap with the proposed Article 5 and the bill would benefit from clarification, please provide suggested language to incorporate into the bill.
