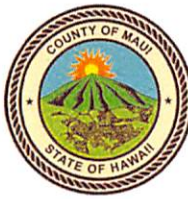

AUTHORIZING THE MAYOR TO SUBMIT AN APPLICATION TO REQUEST THE GOVERNOR OF HAWAII TO INCORPORATE THE EAST MAUI ENTERPRISE ZONE IN THE GREATER MAUI ENTERPRISE ZONE FOR THE DURATION OF THE GREATER MAUI ENTERPRISE ZONE’S TERM, PURSUANT TO SECTION 3.80.050, MAUI COUNTY CODE

WHEREAS, the State of Hawaii previously designated three enterprise zones on the Island of Maui pursuant to Chapter 209E, Hawaii Revised Statutes (HRS), and Chapter 6 of Title 15, Hawaii Administrative Rules (HAR), specifically:

<u>ZONE NAME</u>	<u>DATE DESIGNATED</u>	<u>TERM EXPIRES</u>
Greater Maui Enterprise Zone	May 1, 2006	April 30, 2026
West Maui Enterprise Zone	May 1, 2006	April 30, 2026
East Maui Enterprise Zone	April 1, 2000	March 31, 2020

which are depicted in Exhibit “1”, attached hereto and made a part hereof; and

WHEREAS, a portion of the East Maui Enterprise Zone abuts the Greater Maui Enterprise Zone at the Kula Forest Reserve; and

WHEREAS, Section 3.80.050, Maui County Code, provides that an enterprise zone may be amended if related to changes in zone boundaries, provided such request is approved by the Council of the County of Maui by resolution; and

WHEREAS, the County of Maui desires to enlarge the boundaries of the Greater Maui Enterprise Zone to include all of the area previously designated as the East Maui Enterprise zone, prior to the expiration of the East Maui Enterprise Zone, which would then appear as depicted in Exhibit "2", attached hereto and incorporated herein; now, therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it does hereby authorize the Mayor to submit a request to amend the Greater Maui Enterprise Zone's area to incorporate the East Maui Enterprise Zone in an application to the State Department of Business, Economic Development and Tourism, for processing and recommendation to the Governor; and

2. That certified copies of this resolution be transmitted to the Mayor and the Director of the Office of Economic Development.
