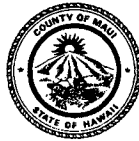

**SUBJECT: FISCAL YEAR QUARTERLY REPORTS (FISCAL YEAR

The Fiscal Year 2018 Budget includes an appropriation of \$5,000,000 for the Employees' Retirement System of the State of Hawaii ("ERS") as it relates to excess pension costs. May I please request the following information:


1. Did the County remit payment to the ERS for the invoices listed above? If yes, provide the date and a copy of the remittance document. If not, explain why the payment has not yet been made.


