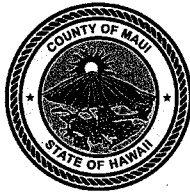

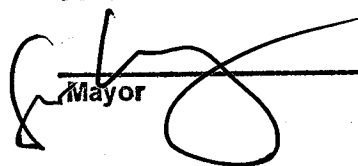

SUBJECT: Taxicab Rate of Fare and Baggage Charges

In accordance with Chapter 5.16.100 of the Maui County Code, the Director of Finance is required to submit to the Council a report reviewing taxicab rate of fare and baggage charges on or before September 1 of each even-numbered year.

The attached **TAXICAB Rates of Fare and Baggage Charges** list the respective rates and fares presently charged by the respective County jurisdictions. Please note that the first column reflects the current rates permitted to be charged in the Maui County Code.

Based on the present rate structure, the following table provides a sampling of the total amount taxicab passengers would be charged. This table does not factor in additional variable charges for waiting times and baggage.

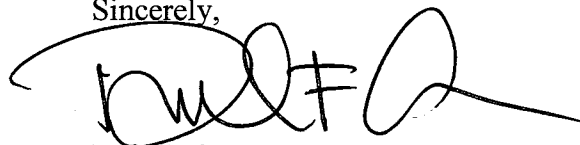
