Chair and Members:

Your Budget and Finance Committee, having met on January 9, 2018, makes reference to County Communication 17-254, from Councilmember Riki Hokama, relating to amendments to Appendix A, Grant Revenue – Schedule of Grants by Departments and Programs for Fiscal Year 2018.

By correspondence dated December 13, 2017, the Budget Director transmitted a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE – SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF POLICE (HIGH INTENSITY DRUG TRAFFICKING AREAS (HIDTA))."

The purpose of the proposed bill is to amend Appendix A, Part I, Grant Revenue – Schedule of Grants by Departments and Programs, Fiscal Year 2018 Budget, by increasing the grant to the Department of Police, High Intensity Drug Trafficking Areas (HIDTA), by \$110,000, for a grant total of \$240,000.

The Budget Director said the Department of Police anticipated \$130,000 in revenue from the HIDTA grant. To date, the Department has received about \$200,000, and anticipates receiving approximately \$40,000 more for Fiscal Year 2018. The grant is from the Executive Office of the President, Office of National Drug Control Policy.

A representative from the Department said the additional funding will be used for overtime costs, training, and equipment to reduce drug trafficking. The representative said the HIDTA program designates a certain amount of funding for each grant applicant. Upon request, applicants may receive additional funding as needed if funds are available.

The representative said Federal forfeiture funds received by the Department generally support drug trafficking activities. He said the activities supported by the HIDTA grant and the forfeiture funds are similar.

Your Committee questioned what type of high-intensity drugs are currently an issue for the County. The representative said while he believes all drugs are currently a community issue, crystal methamphetamine and pharmaceutical drugs are major concerns. The Department also recognizes opioids are becoming a major problem in the community. He said the Department is making every effort to combat drug trafficking.

Your Committee voted 7-0 to recommend passage of the proposed bill on first reading. Committee Chair Hokama and members Atay, Carroll, Cochran, Crivello, King, and Sugimura voted "aye." Committee Vice-Chair White and member Guzman were excused.

Your Budget and Finance Committee RECOMMENDS that Bill _______ (2018), attached hereto, entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2018 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE – SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF POLICE (HIGH INTENSITY DRUG TRAFFICKING AREAS (HIDTA))," be PASSED ON FIRST READING and be ORDERED TO PRINT.

SECTION 1.
