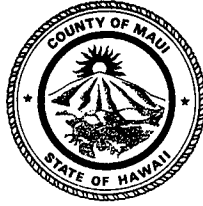

BE IT RESOLVED by the Council of the County of Maui:



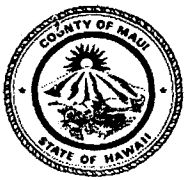
