CHAIR U'U-HODGINS: Good morning. Will the Government Relations, Ethics, and Transparency Committee meeting of June 2nd, 2025, please come to order. - CHAIR U'U-HODGINS: So, we have before us Resol...Resolution 25-109, which would authorize the retention of Marr Jones & Wang, LLLP, as special counsel to represent the County of Maui in pre-litigation negotiations regarding allegations made by Leo Caires, a former County of Maui employ...employee for a total compensation not to exceed \$350,000. At this time, I'm going to please ask for opening comments from Corporation Counsel Victoria Takayesu.
- MS. TAKAYESU: Good morning, Chair. Good morning, Committee Med...Members. We're here today to discuss our request for special counsel due to a conflict. However, before we get started, I'd like to ask that the resolution be amended to include after pre-litigation negotiations to say and litigation. We do believe litigation will be forthcoming. If we could make that amendment, that would be helpful. And then...

- MS. TAKAYESU: And then I can continue on. So, I have received communications from Mr. Caires' attorney. Based on those communications, again, I believe litigation is forthcoming in this action. I also believe that I have...and my department has multiple conflicts with this case. We did discuss this with the Office of Disciplinary Counsel, and I believe once we go into executive session, which I will ask for, that will be evident as to why. Present, I brought today Richard Rand from Marr Jones & Wang. He has, with your approval, agreed to take the case on. He does not have any conflicts. At this time, I would like to request that we could move into executive session to discuss confidential personnel matters as well as litigation issues. Thank you.

ITEM 11(15): RESOLUTION 25-120, AUTHORIZING THE EMPLOYMENT OF SPECIAL COUNSEL KOBAYASHI SUGITA & GODA, LLP, TO REPRESENT COUNTY AUDITOR LANCE TAGUCHI IN THE MATTER OF CHRISTOPHER SALEM'S MAY 8, 2025 COMPLAINT FILED WITH THE STATE OF HAWAI'I DEPARTMENT OF COMMERCE AND CONSUMER AFFAIRS

- CHAIR U'U-HODGINS: Which inclu...which is, rather, Resolution 25-120, which would authorize the retention of Kobayashi Sugita & Goda, LLP, as special counsel to represent the County Auditor Lance Taguchi as a County employee in the matter of Christopher...Christopher Salem...Christopher Salem's May 8th, 2025, complaint filed with the State of [sic] Department of Commerce and Consumer Affairs for a total compensation not to exceed \$150,000. And at this time, I'm going to ask for comments from Deputy Corporation Counsel John Gores.
- MR. GORES: Good morning. We're here today to request the hiring of special counsel to represent Mr. Taguchi with regard to the April 8th, 2025 [sic] complaint Mr. Salem has now brought against Mr. Taguchi at the Department of Commerce and Consumer Affairs concerning Mr. Taguchi's performance of his official duties as County Auditor. This is an extension and a continuation of additional litigation and matters brought by Mr. Salem. Our office has been determined to be disqualified for representation regarding the Chris Salem matters pursuant to the Second Circuit Court decision. Kobayashi Sugita & Goda currently represents the County in the Second Circuit Court matter, and we...they are familiar with this matter, familiar with the allegations, and we're asking to have them appointed.

ITEM 11(16): RESOLUTION 25-121, AUTHORIZING THE EMPLOYMENT OF SPECIAL COUNSEL BEVERIDGE & DIAMOND PC TO ASSIST AND REPRESENT THE DEPARTMENT OF ENVIRONMENTAL MANAGEMENT, COUNTY OF MAUI, WITH THE PERMITTING PROCESS AND LEGAL CHALLENGES ARISING OUT OF THE ISSUANCE OF NPDES PERMIT NO. HI 0021848 FOR THE LAHAINA WASTEWATER FACILITY

CHAIR U'U-HODGINS: So, before us, we have Resolution 25-121, which would authorize the retention of...I should have asked you how to pronounce this before we went in. Breveridge [sic]? How do we...huh? Beveridge? Okay. Beveridge & Diamond PC as special counsel to assist and represent the Department of Environmental Management, County of Maui, with the permitting process and any legal challenges arising out of the issuance of an NPDES permit for the Lahaina Wastewater Facility for a total compensation not to exceed \$250,000. At this time, I'm going to ask for opening comments by Corporation Counsel.

MS. TARNSTROM: Thank you, Chair, Committee Members. This is a matter relating to the Lahaina Wastewater Treatment Facility and its injection wells. And we all know that there was extensive litigation on this, and this is not really related to that litigation. That litigation finished in 2021, where Judge Mollway told us that these Lahaina injection wells needed a Clean Water Act permit and NPDES permit, and...and that issue is done. We're not challenging that issue anymore. Right now, the County has applied for that permit, that NPDES permit. That is a permit that is facilitated by the State Department of Health, even though it is a Federal Clean Water Act permit. So, the State administers that permit. And it is an incredibly complex permitting process. It is literally the first NPDES permit that's been considered for an injection-well-based water treatment facility. So, this is the first time the State, and at this point, the County of Maui, have had to negotiate and figure out the terms of this unique permit in this circumstance. So, the State and the County have been working together since that decision in 2021, trying to coordinate a workable permit and one that the County can operate under, and that had been successful for a while. The State issued a first draft of an NPDES permit some time ago, and that was workable to the County. It had

comments, but it was ultimately a workable draft. Unfortunately, the second draft the DOH released after public comment in April imposed restrictions which might be impossible under current technology for the County wastewater facility to meet, and this puts us in an incredibly difficult position. If that second draft were to be adopted as is, the...we would be in noncompliance immediately with that permit, and that puts us in a position where we might face daily fines that can be pretty extreme. So, that brings us to our...Mr. Silton and the Beveridge & Diamond law firm, with expertise in the Clean Water Act, and specifically in NPDES permitting. The Clean Water Act itself is complex. It requires coordination of Federal statutes and regulations and State statutes and regulations, all of which have to be workable for our Wastewater team to implement all of the standards in order to operate successfully under the permit. And this is, again, where Mr. Silton and Beveridge & Diamond come in. They're not only experienced in the Clean Water Act, but in in NPDES permits specifically and in representing municipalities that have had to figure out how to work under these permits and negotiate with the Department of Health, hopefully on DEM's behalf, to create a workable permit. They also have a deep well of scientific experts to consult, and they essentially just know what they're doing in a very complicated area of law and regulation. And the goal here is to work with DOH to obtain a workable permit, and one that makes sense from a scientific standpoint, and one that our Wastewater guys can actually implement. Again, this has never been issued before, which is part of the reason why we want to make sure we get it right. We'll be operating under this permit for who knows how long, probably decades to come, and hopefully, in a short period of time, we'll be able to obtain the permit and operate under the permit. And in coming years, this will be more of like a rote process, and it won't be so difficult for everybody to wrap their heads around, but we just think it's really important to get this phase right, and...and that's why we want to involve Beveridge & Diamond. And since this is a matter of legal compliance and strategy, we would hope to answer any more questions in executive session, but the Department is here, Director Shayne Agawa is here, as well as Scott Rollins. And Mr. Silton is online, hopefully able to answer questions if you have those too.

- CHAIR U'U-HODGINS: Thank you. DEM, do you guys have anything you want to add in opening comments? Director?
- MR. AGAWA: Hello, can you guys hear me? Oh, yes. Yeah, thank you, Chair U'u-Hodgins. And just a little to add on what Deputy Corp. Counsel Tarnstrom mentioned, she's absolutely correct. We are not trying to get out of the NPDES permit regulations; however, this next...this current draft is so stringent, and I just want to kind of simplify it that if it passes as is, we will be in violation from day one. We are not capable of following the requirements as is. So, you know, we are seeking additional counsel to help us work with DOH; not against DOH, but work with them to come up with a permit and permit requirements that we can work with and...and follow. Thank you.

We have been working with the claimant and have reached a tentative negotiated settlement of 45...\$45,291.47. After looking at the estimates and taking into consideration a number of the items in the claim, claimant's agreeable to this amount.

We have before us Resolution 25-99, which would approve the settlement of the claim filed on May 13th, 2024, which alleges gender discrimination, retaliation, and whistleblower retaliation related to incidents alleged to have occurred between December 17th, 2021, and February 7th, 2024, while the claimant was employed as a business administrator II with the County of the Maui Police Department. At this time, I'm going to request opening comments by Mr. Bradley Sova.

MR. SOVA: Thank you, Chair. I think the synopsis you gave is fairly accurate and it captures all of the opening comments I would make. Yes, this is a claim brought by the former business administrator of the Maui Police Department. It is alleging gender discrimination, retaliation, and whistleblower-law violations in relation to certain employment actions from December of '21 until approximately February of 2024.
