**ACTING ON THE NOMINATIONS OF DUSTIN HAROLD POMAİKAILANI
KALEIOPU AND HEATHER AMY STEPHENS TO THE LIQUOR CONTROL
ADJUDICATION BOARD**

WHEREAS, the Liquor Control Adjudication Board was formed and operates with nine members under Section 2.41.080, Maui County Code, and Sections 8-13, Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, two vacancies will occur on the Liquor Control Adjudication Board when existing terms expire on March 31, 2026; and

WHEREAS, by correspondence dated January 29, 2026, Mayor Richard T. Bissen, Jr. notified the Council he nominated Dustin Harold Pomaikailani Kaleiupu and Heather Amy Stephens listed in Exhibit "A," as attached, as members to the Liquor Control Adjudication Board; and

WHEREAS, the nominations are made in accordance with Section 2.41.080, Maui County Code, and Sections 8-13.3 and 13-2, Revised Charter of the County of Maui (1983), as amended; and

WHEREAS, Charter Section 13-2(17) requires the Council to approve or disapprove the Mayor's nomination within 30 days after the Mayor submits the name of the nominee to the Council and, if the Council disapproves the nominee, to immediately notify the Mayor and the Independent Nomination Board of the Council's action; now therefore,

BE IT RESOLVED by the Council of the County of Maui:

1. That it approves the appointment of the persons listed in Exhibit "B," as attached, as members to the Liquor Control Adjudication Board for the term expiring on March 31, 2031;
2. That it disapproves the appointment of the person(s) listed in Exhibit "C," as attached, as members to the Liquor Control Adjudication Board as nominated by the Mayor;
3. That the Council expresses its gratitude and appreciation to the nominees for their willingness to be considered for public service and actively participate in County government; and


