

SUBJECT: AMENDMENTS TO THE FISCAL YEAR 2026 BUDGET (APPENDIX A, PART I; DEPARTMENT OF MANAGEMENT; PRIVATE DONATIONS)

On behalf of the Department of Management, I am transmitting the following:

1. A proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2026 BUDGET; APPENDIX A, PART I; DEPARTMENT OF MANAGEMENT; PRIVATE DONATIONS; NEW APPROPRIATION OF \$10,000."

The purpose of the proposed bill is to amend the Fiscal Year 2026 Budget, Appendix A, Part I, Grants and Restricted Use Revenues -Schedule of Grants and Restricted Use Revenues by Departments and Programs for Fiscal Year 2026, to add a new appropriation under the Department of Management, entitled "Private Donations" in the amount of \$10,000.

The purpose of the proposed resolution is to authorize the acceptance of a donation of \$2,487.31 from Fukuyama City, Japan, to help the County's recovery from the August 8, 2023 wildfires.

3. A proposed resolution entitled "AUTHORIZING ACCEPTANCE OF A DONATION OF \$1,316 FROM WESTMINSTER CHRISTIAN ACADEMY, TO HELP WITH RECOVERY FROM THE AUGUST 2023 MAUI WILDFIRES, UNDER SECTION 3.56.030, MAUI COUNTY CODE".
