- Volunteer Community Clean Up on Holomua Rd to build community relations through mālama 'āina a mālama po'e.

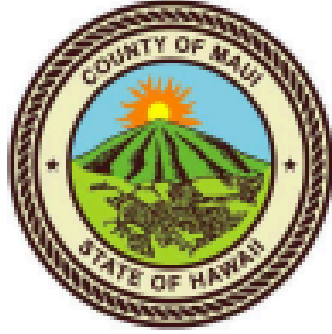
