This letter is in response to the Budget, Finance, and Economic Development Committee letter, dated October 27, 2023. As requested, we are providing the following responses to your request:

1. Does the Department have a current bid for the vehicles? If so, what is the bid price and how long will the vendor honor the bid?

Yes, the Department does have a current bid: IFB23-24/P-43 Contract C8055, indicating the bid price of \$1,449,314.82. The Vendor will likely only honor the bid for as long as the vehicle Manufacturer will accept orders for that model year. The vendor/contractors are not to place any orders until the contract is completed and a Notice to Proceed is issued.
