This bill proposes to amend the FY 2023 Budget by increasing the estimated revenues for Carryover/Savings from the General Fund by \$10,000,000 appropriating the funds to the Department of Finance, Countywide Costs, Temporary Hazard Pay related to COVID-19 Grievances.

Bill 204"A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.48. MAUI COUNTY(2022)CODE, RELATING TO REAL PROPERTY DEDICATED AS 'ĀINA KŪPUNA"

This bill proposes to amend Subsection B of Section 3.48.361, Maui County Code, by changing the required aggregate real property taxes assessed on a property for the ten tax years prior to an initial application for a dedication of real property as 'āina kūpuna from exceeding \$50,000 to exceeding \$10,000.

This bill proposes to authorize the Mayor of the County of Maui to enter into an intergovernmental agreement with the State of Hawaii for an assignment of lease from the State of Hawaii to the County of Maui for approximately 100 acres of land, described as tax map key (2) 4-9-002:001 (POR), for the purpose of establishing the Lāna'i Agricultural Park.

This bill proposes to amend Title 3, Maui County Code, to establish a Parking Revenue Fund to generate funding for the County's parking operations, including maintenance, repair, security, safety, improvement, equipment, beautification, expansion, staff compensation, parking facility bond payments, and other related costs. Bill 154, CD1, FD1 (2022) "A BILL FOR AN ORDINANCE AMENDING TITLES 2, 16, 18, 19, AND 20, MAUI COUNTY CODE, TO ESTABLISH CULTURAL OVERLAY MAP AND CULTURAL SENSITIVITY DESIGNATIONS"

This bill proposes to establish a cultural overlay map, cultural sensitivity designations, and related review processes to preserve cultural resources and promote careful planning.

Bill 192"A BILL FOR AN ORDINANCE AMENDING CHAPTER 3.48, RELATING TO REAL(2022)PROPERTY TAX CLASSIFICATIONS AND EXEMPTIONS"

This bill proposes to amend Chapter 3.48, Maui County Code, to promote equity in Real Property Tax, including by replacing the Short-Term Rental home classification with a TVR-STRH classification and ensuring that property owners who are effectively renting to themselves are not eligible to be classified Long-Term Residential.

This bill proposes to amend Ordinance No. 5392, Bill No. 69, CD1, FD2 (2022), the "Fiscal Year 2023 Budget" of the County of Maui, by amending:

- 1. Section 2, Estimated Revenues, by increasing Bond/Lapsed Bond in the amount of \$3,350,000; and by increasing the Total Estimated Revenues in the amount of \$3,350,000;
- 2. Section 4.E.6.a.(1).(ii)., Department of Parks and Recreation, Wailuku-Kahului Community Plan Area, Parks and Recreation, Bond Fund by increasing the appropriation for the War Memorial Gym Building Improvements by \$3,350,000;
- 3. Total Capital Improvement Project Appropriations to reflect an increase of \$3,350,000; and
- 4. Total Appropriations (Operating and Capital Improvement Projects) to reflect an increase of \$3,350,000.

This bill proposes to amend Ordinance No. 5394, Bill No. 71, CD1, FD2 (2022), relating to the issuance of General Obligation Bonds of the County of Maui, by increasing the appropriation for the Department of Parks and Recreation, Wailuku-Kahului Community Plan Area, Parks and Recreation, War Memorial Gym Building Improvements by \$3,350,000 for a total bond principal amount not to exceed \$164,748,838.
