BILL 4 (2023), CONVERTING APARTMENT BUILDINGS FROM TRANSIENT VACATION RENTAL USE TO LONG-TERM RESIDENTIAL USE (DRIP-1)

<u>Description:</u> The Committee is in receipt of the following:

- Bill 4 (2023), entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 19.12. MAUI COUNTY CODE. RELATING TO CONVERTING **APARTMENT BUILDINGS FROM** TRANSIENT VACATION RENTAL USE TO LONG-TERM RESIDENTIAL USE." 4's purpose is to allow property owners of buildings located in the Apartment District to permanently convert property from transient vacation rental use to long-term residential use by filing a declaration with the State of Hawai'i Bureau of Conveyances and providing notice to the County.

The purpose of the proposed bill is to allow property owners of buildings located in the Apartment District to convert real property voluntarily and permanently from transient vacation rental use to long-term residential use by filing a declaration with the State of Hawai'i Bureau of Conveyances and providing notice to the County.
