<u>Description:</u> The Committee is in receipt of the following:

- 1. Resolution 22-260, entitled "APPOINTMENTS TO THE EAST MAUI REGIONAL COMMUNITY BOARD." Resolution 22-260's purpose is to approve or disapprove applicants for the seven Council-appointed positions to the East Maui Regional Community Board.
