NOTICE IS HEREBY GIVEN that a public hearing will be held by the Council of the County of Maui, State of Hawaii, on Friday, May 12, 2023, beginning at 2:30 p.m., or soon thereafter, via BlueJeans link https://maui.bluejeans.com/295235670, with in person testimony and viewing available at the Council Chamber, Kalana O Maui Building, 8th Floor, 200 South High Street, Wailuku, Hawai'i, for the purpose of receiving testimony, pursuant to Section 249-13, Hawaii Revised Statutes, and Section 3.24.030, Maui County Code, regarding the Motor Vehicle Weight Tax rates for Fiscal Year 2024:

- 1. Effective January 1, 2024, \$0.035 per pound of net weight for passenger vehicles, and trucks and noncommercial vehicles not exceeding 6,500 pounds (no change).
- 2. Effective January 1, 2024, \$0.0541 per pound of net weight for all other motor vehicles (currently \$0.0536).
- 3. Minimum tax for any motor vehicle is \$15 (no change). Penalty for delinquent tax is \$8 for passenger vehicles (no change) or \$20 for other vehicles (no change).

TESTIMONY PROCEDURES

Individuals may provide oral testimony by phone or video conference. To join the meeting by phone, call 1-408-317-9253 and input meeting code 295235670. To join by video conference, use the following link: https://maui.bluejeans.com/295235670.

Each testifier shall be allowed to speak for up to three minutes. If approved by the presiding officer and announced prior to any oral testimony being taken, the testifier may be allowed one minute to conclude their testimony. The time limits for testimony at a public hearing may be modified, if the modification is initiated by the presiding officer and approved by a majority of the

Council; provided that a modification would apply equally to all testifiers. No further oral testimony by the testifier shall be permitted. An individual's request to testify may be deemed withdrawn if the individual does not answer when called to testify.

If a testifier wishes to testify anonymously, please indicate that request in the Bluejeans chat or with staff at the sign-up desk outside the Council Chamber. Anonymous testifiers will be assigned a number.

DECORUM

Any person who behaves in a manner that disrupts, disturbs, or impedes the orderly conduct of the Council public hearing may, at the discretion of the presiding officer or a majority of present Councilmembers, be removed from the Council Chamber or, if participating remotely, muted or dropped from the public hearing. Disruptive behavior includes, but is not limited to: heckling, shouting, use of profanity, and threatening remarks made to any member of the Council, staff, or general public.
