# PROPOSED FISCAL YEAR 2025 BUDGET FOR THE COUNTY OF MAUI (BFED-1)

**Description:** The Committee is in receipt of correspondence dated March 25, 2024, from Mayor Richard T. Bissen, Jr., relating to the proposed Fiscal Year ("FY") 2025 Budget for the County of Maui. Included in the Mayor's transmittal are the following:

- 1. Bill 60 (2024), entitled "A BILL FOR AN ORDINANCE RELATING TO THE OPERATING BUDGET FOR THE COUNTY OF MAUI FOR THE FISCAL YEAR JULY 1, 2024 TO JUNE 30, 2025." Bill 60's purpose is to appropriate estimated revenues for the operating and capital improvement budget. Incorporated within Bill 60 are Appendix A, which lists Grants and Restricted Use Revenues and Special Purpose Revenues; Appendix B, which is the Schedule of Fees, Rates, Assessments, and Taxes; Appendix B-1, which lists the County's concessions, leases, and licenses by department; and Appendix C, which provides descriptions of Capital Improvement Projects ("Budget bill").
- 2. Bill 61 (2024), entitled "A BILL FOR AN ORDINANCE RELATING TO THE CAPITAL PROGRAM FOR THE FISCAL YEAR ENDING JUNE 30, 2025." Bill 61's purpose is to set forth the Capital Program for FYs 2025 through 2030. Incorporated within Bill 61 are Appendix A-1, a report entitled "COUNTY OF MAUI, CAPITAL IMPROVEMENT PROJECTS REPORT, AS OF DECEMBER 31, 2023," which lists all pending capital improvement projects and

appropriations, except for Water Fund projects, as of December 31, 2023; Appendix A-2, a report entitled "County of Maui, Capital Improvement Program by District Job and Index, Fiscal Year Ending 6/30/2024 - as of 12/31/2023," which includes pending Water Fund capital improvement projects and appropriations as of December 31, 2023; and Appendix B, which is the proposed Capital Program for FYs 2025 through 2030 ("Capital Program bill").

- 3. Bill 62 (2024),entitled "А BILL FOR AN ORDINANCE AUTHORIZING THE ISSUANCE OF SIXTY-ONE MILLION THREE THOUSAND HUNDRED SEVENTY-THREE EIGHT HUNDRED DOLLARS (\$61,373,839) AGGREGATE THIRTY-NINE PRINCIPAL AMOUNT OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI FOR THE PURPOSE OF PROVIDING FUNDS TO PAY ALL OR A PART OF THE COST OF APPROPRIATIONS FOR PUBLIC IMPROVEMENTS OF AND FOR THE COUNTY OF MAUI; THE FORM, DENOMINATIONS AND CERTAIN OTHER FIXING FEATURES SUCH BONDS AND PROVIDING FOR THEIR OF SALE: AUTHORIZING THE DIRECTOR OF FINANCE TO DETERMINE CERTAIN DETAILS OF THE BONDS: AUTHORIZING THE ISSUANCE AND SALE OF A LIKE PRINCIPAL AMOUNT OF **GENERAL** OBLIGATION BOND **ANTICIPATION** NOTES IN OF ANTICIPATION THE ISSUANCE AND SALE OF SUCH OF BONDS; **AUTHORIZING** THE ISSUANCE REFUNDING GENERAL OBLIGATION BONDS OF THE COUNTY: AND **ACTIONS** TO PROVIDING FOR OTHER RELATED THE ISSUANCE, SALE AND DELIVERY OF SAID BONDS." Bill 62's purpose is to authorize the issuance of \$61,373,839 in general obligation bonds for various capital improvement projects ("Bond Authorization bill").
- 4. Bill 63 (2024),entitled "A BILL FOR AN ORDINANCE DETERMINING THAT PART OF THE PROCEEDS OF GENERAL OBLIGATION BONDS OF THE COUNTY OF MAUI HERETOFORE ISSUED IS IN EXCESS OF THE AMOUNTS REQUIRED FOR THE PURPOSES FOR WHICH SUCH BONDS WERE INITIALLY ISSUED, OR MAY OR SHOULD NOT BE APPLIED TO THOSE PURPOSES. AND DIRECTING SUCH PROCEEDS TO OTHER PUBLIC IMPROVEMENTS OR AUTHORIZED PURPOSES OF THE COUNTY OF MAUI." Bill 63's purpose is to reauthorize the use of \$4.811,161 in lapsed bond proceeds for the Department of Public Works, West Maui Community Plan Area, Road Improvements (and improvements, beautification, sidewalks, related bike paths. drainage, bridge repairs, and maintenance safety and utilities, accessibility for persons with disabilities) including: (1) Front Street Sidewalk, Railing, and Seawall Repair ("Lapsed Bond bill").
- (2024), 5. Bill 64 entitled "А BILL FOR AN ORDINANCE AUTHORIZING THE MAYOR OF THE COUNTY OF MAUI TO ENTER INTO AN INTERGOVERNMENTAL AGREEMENT FOR A LOAN FROM THE STATE OF HAWAII'S WATER POLLUTION

CONTROL REVOLVING FUND FOR VARIOUS WASTEWATER PROJECTS, FISCAL YEAR 2025 BUDGET ORDINANCE." Bill 64's purpose is to authorize the Mayor to enter into an intergovernmental agreement to finance the Napili No. 1 Force Main Replacement and the Lahaina Wastewater Reclamation Facility Returned Activated Sludge (RAS)/Dewatering Upgrades with funds not to exceed \$10,700,000.

- Resolution 24-66, entitled "ADOPTING THE FUEL TAX RATES FOR THE COUNTY OF MAUI, EFFECTIVE JULY 1, 2024." Resolution 24-66's purpose is to adopt the fuel tax rates for the County of Maui, effective July 1, 2024, in accordance with Section 243-5, Hawaii Revised Statutes, and Section 3.20.010, Maui County Code.
- 7. A document entitled "COUNTY OF MAUI BUDGET PROPOSAL FISCAL YEAR 2025," which includes the Mayor's Budget Message ("Program Budget").
- **Status:** The Committee may consider whether to recommend passage on first reading of each of the following bills with or without revisions: Bill 60 (2024), Bill 61 (2024), Bill 62 (2024), Bill 63 (2024), and Bill 64 (2024). The Committee may also consider whether to recommend adoption of Resolution 24-66, with or without revisions. The Committee may also consider the development of other legislation related to the proposed budget for FY 2025. The Committee may also consider whether to recommend the filing of Bill 60 (2024), Bill 61 (2024), Bill 62 (2024), Bill 63 (2024), Bill 64 (2024), and Resolution 24-66, and other related action.
  - <u>Note:</u> With reference to this agenda item, one or more executive meetings may be held in accordance with Section 92-5(a), Hawaii Revised Statutes ("HRS"):
    - (1) to consider and evaluate personal information relating to individuals applying for professional or vocational licenses cited in Section 26-9, HRS, or both;
    - (2) to consider the hire, evaluation, dismissal, or discipline of an officer or employee or of charges brought against the officer or employee, where consideration of matters affecting privacy will be involved; provided that if the individual concerned requests an open meeting, an open meeting shall be held;
    - (3) to deliberate concerning the authority of persons designated by the County, the Council, or the Committee to conduct labor negotiations or to negotiate the acquisition of public property, or during the conduct of such negotiations;
    - (4) to consult with legal counsel on questions and issues pertaining to the powers, duties, privileges, immunities, and liabilities of the County, the Council, and the Committee;
    - (5) to investigate proceedings regarding criminal misconduct;
    - (6) to consider sensitive matters related to public safety or security;
    - (7) to consider matters relating to the solicitation and acceptance of

private donations; and

(8) to deliberate or make a decision upon a matter that requires the consideration of information that must be kept confidential pursuant to a State or Federal law, or a court order.
