RESOLUTION 25-79, SETTLEMENT AUTHORIZATION: KAMALANI T. UEHARA V. COUNTY OF MAUI, DEPARTMENT OF WATER SUPPLY, ET AL., CIVIL 2CCV-21-0000378 (GREAT-11(6))

Description: The Committee is in receipt of the following:

1. Resolution 25-79, entitled “AUTHORIZING SETTLEMENT OF KAMALANI T. UEHARA vs. COUNTY OF MAUI, DEPARTMENT OF WATER SUPPLY, ET AL.; CIVIL 2CCV-21-0000378.” Resolution 25-79’s purpose is to approve settlement of the claim, filed on December 10, 2021. If audiovisual connection is lost at the official location for in-person testimony and viewing, the committee will be in recess for up to 30 minutes to restore connectivity.
