**SPECIAL STOPS AT INTERSECTIONS - AKALA DRIVE AT MIKIOI PLACE (KIHEI) AND LIMAHANA PLACE AT HINAU STREET (LAHAINA) (IEM-22)**

**Description:** The Committee is in receipt of County Communication 15-107, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 10.44, MAUI COUNTY CODE, RELATING TO SPECIAL STOPS." The purpose of the proposed bill is to: 1) update the Code to delete the stop requirement at Mikioi Place for vehicles traveling along Akala Drive, Kihei, Maui, Hawaii, and 2) establish a stop requirement at Hinau Street for vehicles traveling along Limahana Place, Lahaina, Maui, Hawaii.
