<u>Description:</u> The Committee is in receipt of correspondence dated April 29, 2016, the Department of the Corporation Counsel, requesting consideration resolution, entitled "AUTHORIZING of а proposed SETTLEMENT OF COUNTY OF MAUI V. LANAI WASTE REMOVAL, INC., ET AL., CIVIL NO. 15-1-0476(2)," and transmitting a copy of the The complaint alleges Defendants Lanai Waste Removal, Inc.; Lanai Trucking, Inc.; Charlene Amoral; and Manuel Amoral, Jr. have, as of the date of the filing of the complaint, accumulated \$321,019.22 in past-due tipping (commercial landfill disposal) fees owed to the County for the disposal of waste at the Lanai Landfill at Kaumalapau Highway, Lanai, and are in breach of a Repayment Agreement previously entered into with the County. The purpose of the proposed resolution is to authorize settlement of the case.
