- **Description:** The Committee is in receipt of Bill 78 (2015), entitled "A BILL FOR AN ORDINANCE AMENDING THE COMPREHENSIVE ZONING ORDINANCE RELATING TO WET BARS IN DWELLING UNITS." The purpose of Bill 78 (2015) is to establish in the Comprehensive Zoning Ordinance a definition for "wet bar" and to limit the number of wet bars in dwelling units.
