- **DESCRIPTION:** The Committee is in receipt of County Communication 16-291, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, CIVIL DEFENSE AGENCY (STATE HOMELAND SECURITY GRANT (SHSG) PROGRAM)." - **DESCRIPTION:** The Committee is in receipt of County Communication 16-292, from the Budget Director, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING THE FISCAL YEAR 2017 BUDGET FOR THE COUNTY OF MAUI AS IT PERTAINS TO APPENDIX A, PART I, GRANT REVENUE SCHEDULE OF GRANTS BY DEPARTMENTS AND PROGRAMS, DEPARTMENT OF HOUSING AND HUMAN CONCERNS (KAISER FOUNDATION HEALTH PLAN)." ### **DESCRIPTION:** The Committee is in receipt of the following:

- 1. Correspondence dated November 7, 2016, from the Budget Director, transmitting a proposed resolution to transfer funds from one category of use to another, within the Department of Public Works, to fund needed equipment, professional services, and training for the respective programs. The proposed amendment would allow for expenditures in the proper category of use.
- 2. Correspondence dated November 16, 2016, from the Budget Director, transmitting a revised proposed resolution entitled "AUTHORIZING THE TRANSFER OF AN UNENCUMBERED APPROPRIATION BALANCE WITHIN THE DEPARTMENT OF PUBLIC WORKS, FISCAL YEAR 2017 BUDGET." The funds will be used for equipment, professional services, and training for the respective programs.
