#### **SECTION 10.48.040**, MAUI COUNTY CODE, RELATING AMENDING TO ON **CERTAIN** PARKING **PROHIBITIONS** STREETS AND **HIGHWAYS (MT-7)**

**Description:** The Committee is in receipt of County Communication 18-394, from the Director of Public Works, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING SECTION 10.48.040, MAUI COUNTY RELATING TO PARKING **PROHIBITIONS** ON **CERTAIN** CODE. STREETS AND HIGHWAYS." The purpose of the proposed bill is to prohibit parking on the north side of Onaha Street in Waiehu, the west side of Kaiola Street in Kihei, and on the east side of Hua Place in Kihei; and to delete Section 10.48.040(G), Maui County Code, and reinsert it as Section 10.48.040(A)(50).

**Status:** The Committee may consider whether to recommend passage of the proposed bill on first reading, with or without revisions. The Committee may also consider the filing of County Communication 18-394 and other related action.
