USE AND SALE OF RESTRICTING THE SINGLE-USE **PLASTIC DISPOSABLE FOODWARE (EACP-16)**

Description: The Committee is in receipt of County Communication 18-430, from Councilmember Elle Cochran, transmitting a proposed bill entitled "A BILL FOR AN ORDINANCE ESTABLISHING A NEW CHAPTER 20.24, MAUI COUNTY CODE, RELATING TO RESTRICTING THE USE AND SALE OF SINGLE-USE PLASTIC DISPOSABLE FOODWARE." The purpose of the proposed bill is to promote public health, reduce litter, and limit harmful materials from entering the environment by regulating and limiting the use and sale of single-use plastic disposable foodware by food providers, and to encourage the use of environmentally preferred alternatives, such as containers, straws, and utensils made from compostable materials.

Status: The Committee may receive a presentation from Ashley O'Colmain of Maui Huliau Foundation and other resource people, regarding the current use of plastic disposable foodware and the impacts the proposed bill may have on Maui County. The Committee may also discuss the matter. legislative action will be taken.

PLASTIC BAG REDUCTION (EACP-2)

<u>Description:</u> The Committee is in receipt of the following:

1. County Communication 16-62, from Councilmember Elle Cochran,

- transmitting a proposed bill relating to plastic bag reduction.
- 2. Correspondence dated November 3, 2016, from the Department of the Corporation Counsel, transmitting a revised proposed bill entitled "A BILL FOR AN ORDINANCE AMENDING CHAPTER 20.18, MAUI COUNTY CODE, RELATING TO PLASTIC BAG REDUCTION." The purpose of the revised proposed bill is to: 1) simplify and strengthen the definitions of "plastic bag" and "reusable bag"; 2) exempt plastic bags used for specified purposes from the plastic bag prohibition; 3) repeal the requirement for annual reporting by the Department of Environmental Management; and 4) prohibit businesses from providing prohibited plastic bags to their customers at any time, not just at the point of sale.

<u>Status:</u> The Committee may discuss the matter. No legislative action will be taken.
